- (1) I/ We am/ are holding the license No. _____ for conducting the trade of _____ at _____, along with C.F.O. N.O.C. u/n _____ dated _____.
- (2) I/ We state that I/ We have applied for renewal of the said license no. _____ for conducting the trade of _____ at _____. (hereinafter referred to as “the said premises”)
- (3) I/ We state that I/ We have gone through the earlier stipulated requirements/ fresh codified requirement of Mumbai Fire Brigade on MCGM portal/ Maharashtra Fire Prevention and Life Safety Measures Act, 2006 to be complied in respect of the above said trade and I/ We hereby declare that all the fire safety measures are complied all the time by me/ us. I/ We shall not indulge into any activity which may cause fire/ health hazard and against the provisions of law.
- (4) I/ We say and undertake that wherever applicable Fire Resistance Door is installed in the said premises.
- (5) I/ We say and undertake that I /we have carried out Electric Audit from Govt. approved electrical inspector for electrical fittings / fixtures installed in the premises are as per The Electricity Act, 2003 and the Rules.
- (6) I/ We say and undertake that as per the provisions of Section 3(3) of The Maharashtra Fire Prevention and Life Safety Measures Act, 2006 and Rule 4(1)/ Rule 1(2) of the Maharashtra Fire Prevention and Life Safety Measures Rules, 2009, I /we have acquired Form-A and/ or Form-B Certificate from authorized Licensed agency regarding Fire-Fighting and Fire-Protection system/ equipment is installed on the said premises. (if applicable)

- (7) I/ We say and undertake that the said premises will be maintained fire compliant.
- (8) I/ We say and undertake that LPG/ PNG installation is tested by authorized contractor and the same are in good working condition.
- (9) I/ We say and undertake that Heat/ Hot gases and smoke are disposed off in safe manner in accordance with the provisions of Maharashtra Pollution Control Board.
- (10) I/ We say and undertake that I/ We have not carried out/ shall not carry out any unauthorized construction/ electrical fittings and/ or otherwise which is against the provisions of Law.
- (11) I/ We say and undertake that, if it is revealed during the course of inspection of the said premises, by competent authority, and if it is found that the codified requirements of Mumbai Fire Brigade/ requirement as per Maharashtra Fire Prevention and Life Safety Measure Act, 2006 and Public Health Department are not complied by me / us and also any unauthorised construction is/ are found carried out by me/ us, then the MCGM shall be at liberty to suspend/ revoke the aforesaid license by following due process.
- (12) I/ We undertake that I/ We shall abide and comply all the codified requirements of Mumbai Fire Brigade/ requirements as per Maharashtra Fire Prevention and Life Safety Measures Act and Public Health Department as amended from time to time.
- (13) I/ We hereby Indemnify the MCGM from and against all actions, acts, costs, claims, damages, demands of any nature and kind whatsoever, which may be instituted, claimed or made against the MCGM its officers, servants and agents and the Municipal Commissioner for MCGM by any person or persons, any third party or legal entity by reasons of the MCGM having granted to me/ us the said health license under Section 394 of Mumbai Municipal Corporation Act , 1888.
- (14) I/ We are aware and accept that I/ We shall be liable to civil as well as criminal prosecution in the event information submitted by me/ us are found to be false and/ or incorrect and License fee/ deposit amount paid by me/ us shall be forfeited.

(15) I/ We say and undertake that the undertaking is binding on me/ us my/ our/ its legal heirs/ representatives/ partners/ directors who are responsible for the acts done by the company/ firm from time to time.
