PART-2

TERMS AND CONDITIONS FOR BEAUTY PARLOUR

1. Beauty Parlour is of sufficient size with a floor space of not less than 10' x 10' and not less than 9 ft. in height, is properly lighted and ventilated as approved by the Executive Health Officer.
2. The whole of the floor is paved or covered with material, the upper surface of which is smooth, even and impervious to dust, and the premises is lime-washed twice a year.
3. The floor is swept at least three times a day, (a) before commencement of the work, (b) at noon and (c) at the close of each day's work.
4. All tables have smooth and even surface and are washed and cleaned daily and kept free from accumulations of hair.
5. The brushes are made of good material and are thoroughly washed, cleaned and sterilized every day before use.
6. For the collection of hair and sweepings, a moveable sanitary bin made of galvanized iron or other equally suitable and imperious material is provided and kept covered with a gloze fittings lid.

7. All hair and sweepings are collected at frequent intervals and deposited in the sanitary bin, the contents of which are emptied twice a day into a Municipal dust bin cart.
8. Within or adjoining the Beauty Parlour a washing place with water laid on from the Municipal water supply is provided.
9. All basins for washing, and all sinks and washing places in the premises are efficiently drained by pipes which shall if necessary be trapped and which shall be disconnected from any pipe or gully which communicates directly with a faecal drain.
10. The Beauty Parlour is provided with means for securing a supply of boiling water adequate for the purpose of sterilizing implements and washing the appliances in daily use.
11. Approved and standard cosmetics and other chemicals for facials and other beauty care are used.
12. In case milk shop or flour mill is adjacent to the Beauty Parlour then the parlour is air-conditioned along with automatic door closer.
13. The parlour will ensure proper disposal of waste generated without causing nuisance to surrounding trades.
