Whereas, the State Government in Urban Development Department has amended Section 124F of the Maharashtra Regional and Town Planning Act, 1966 as the Maharashtra Regional and Town Planning (Amendment) Ordinance, 2015 (Maharashtra ordinance VI of 2015). (hereinafter referred to as "the said Act");

And whereas, amended sub-section (2) of Section 124F of the said Act empowers State Government to partially exempt the payment of development charge payable on the development of any land or building which is proposed for warehouse or godown;

And whereas, the Municipal Commissioner, Municipal Corporation of Greater Mumbai has requested to grant exemption in development charges to the extent of 90% for warehouse/godowns to promote these activities in terms of e-commerce and e-trading;

Now therefore, in exercise of its power under sub-section (2) of amended Section 124F of the said Act, the Government of Maharashtra hereby partially exempts the payment of development charge payable on the development of any land or building proposed for warehouse or godown, in the area of Municipal Corporation of Greater Mumbai to the extent in the schedule appended below;

## SCHEDULE

1)	Development of land for warehouse or godown use, also involving any building or construction operations.	90%

The Muncicipal Corporation of Greater Mumbai within its jurisdiction shall be entitled to pass an order to exempt the payment of development charges payable on the development of any land or building which is proposed for warehouse or godown to the extent indicated above.
