### CIRCULAR

Sub: Grant of permission for erection of Pandals / temporary structures on roads, footpaths etc. and receiving complaints of Noise Pollution.

Ref: 1) Hon.'ble High Court orders in P.I.L. No. 173 of 2010 dt. 13.3.2015, 24.6.2015, 17.7.2015 and 10,11,12 & 16<sup>th</sup> August 2016.

- 2) MCGM policy on subject u/no. AMC/ES/4462/III dt. 24.7.2015.
- 3) Circular No.MDF/OD/3098/Gen.dt.30.01.2017

Hon'ble High Court vide orders dt. 10,11,12 & 16<sup>th</sup> August 2016 given various directions on the subject to State Govt. and all Municipal Corporations etc. In compliance of the same, following directions are being issued to all Ward Asstt. Commissioners & concern HODs.

- 1. Law Officer has already communicated the orders of Hon.'ble High Court by email to all Ward Asstt. Commissioners, Zonal DMCs and HODs. All Ward Asstt. Commissioners are directed to go through the orders dt. 16.8.2016(the directions given in para 93 & 94 pg.108 to 139).
- 2. All Ward / Asstt. Commissioners while granting permission for erection of temporary booths/ structures etc. on streets, following condition should be inserted in permission letter... "The loud speaker or a public address system shall not be used except after obtaining written permission from the authority contemplated by the Noise Pollution Rules in accordance with sub rule(1) of Rule 5 in addition to the licence required to be obtained under the Rules, if any, framed under the Maharashtra Police Act 1951."
- 3. The complaints received from all modes regarding violation of Noise Pollution and Unauthorized Pandals on Streets should be received by Complaint Redressal Officers of the Ward, staff of Disaster Management. Complaints received should be entered in the Registers separately in enclosed formats. (Attachment 1). All complaints received should be forwarded to respective Police Stations/ Police Control Department immediately. After forwarding the complaints to respective Police Station/Police Control Deptt., necessary information should be sent to Disaster Control Unit for uploading on MCGM website. DMU to upload the information on MCGM website and also to be sent to District Collector Office for uploading on Govt. website.
- 4. As per Home Deptt. Notification dt. 14.7.2015 (copy enclosed. Attachment 2), Govt. has declared authorities/ designated officers for the purpose of control of noise pollution every police station area, the officer not below the rank of Inspector of the

respective police station. All Ward Asstt. Commissioners are directed to write letters to all Senior Police Inspectors of their respective area and obtain details(names, designations, telephone nos. and address of police station) of designated officers appointed under Maharashtra Police Act 1951 for the purpose of control of noise pollution. The compiled list of designated officers should be displayed on notice board of Ward and one copy should be sent to Public Relation Officer (PRO) for publishing the same on MCGM website, District Collector Offices website etc. PRO should send one copy of the same to District Collector Office for publishing the same on the notice boards of all Revenue Offices. PRO should publish this compiled list in newspapers and local TV cable network before every major festival.

- 5. The staff receiving complaints should not disclose the details of complainants and secrecy should be maintained.
- 6. Before the commencement of every major festival like Ganeshotsav, Navratri, Dahi Handi etc., all Ward Asstt. Commissioners shall convene the meeting of all major organizations holding such functions. Local political leaders, members of Mohalla Committee, officials of various Mandals etc. should be invited in the meeting and appraise them of the provisions of law and the consequences of breach of the provisions of law. The meetings shall be to impress upon everyone to abide by the Noise Pollution Rules and the relevant provisions of statutes concerning regulation of construction of temporary booths/pandals on the streets, etc.
- 7. All Ward Asstt. Commissioners should follow strictly the Hon'ble High Court Orders /directions read with BMC policy issued u/no.AMC/ES/4462/111 dt.24.7.2015 while granting permission for erecting temporary Pendals/ booths/structures on streets (including footpaths/footways) under section 317 of MMC Act 1888 for holding festivals/ ceremonies etc. In the permission letter, condition should be laid down that ``the copy of the permission should be displayed on the pandal prominently, failing which the structure will be treated as unauthorized and will be demolished."
- 8. As per circular no. MDF/OD/3098/Gen. dt. 30.01.2017, in every ward, `Unauthorized Pandal Detection Team' under the leadership of Ward Executive Engineer is required to be established by respective Ward Asstt. Commissioners. This team should visit entire area of the ward atleast before 7 days of every major festivals during the year, also during the period of festival and detect unauthorized Pandals on roads/ footpaths etc. and inform concern/ respective Asstt. Engr. (Maint.) of the ward for taking necessary action with copy to Ward Asstt. Commissioner. All Asstt. Commissioners of respective Ward should ensure that no unauthorized Pandals/Booths/ Structure are erected on street/Footpath/Footways. If they are erected or erection is under progress, with help of police same should be removed as Revenue officers of Government will report the said unauthorised Pandals to the Hon'ble High Court. Even Idols are installed still removal action be taken against unauthorised Mandap/Pandals etc. This team should ensure that all unauthorized pandals are detected and taken necessary action on the same.

- While exercising the power under section 317 of MMC Act 1888, Ward Asstt.
   Commissioners shall be bound to ensure that the fundamental rights of citizens to have footpaths and/or footways in a reasonable condition and free of obstruction is not violated.
- 10. All Ward Asstt. Commissioners to ensure that the reports received from Revenue Officers Team regarding unauthorized pandals on streets should be checked immediately with office records and prompt action is taken on unauthorized pandals. Register in the enclosed format (Attachment 1) should be maintained and after taking necessary action, compiled report should be sent to Zonal D.M.C., D.M.C.(Z-II) and Chief Officer (Disaster Management Unit).
- 11. Ward Asstt. Commissioners are directed to issue orders nominating concern Asstt. Engr. (Maint.) of the ward as responsible officer to attend the complaints of unauthorized Pandals on streets. Complaints regarding unauthorized pandals / structures on streets should be attended by the respective Asstt. Engr. (Maint.) and Jr. Engr. (Maint.) of the ward within 24 hours. Ward / Asstt. Commissioners to review the complaints and `Action Taken Report' on daily basis. If the complainants are not satisfied with the redressal, they can appeal to Zonal D.M.Cs.
- 12. All Asstt. Commissioners of respective Wards should fix responsibility on Officer to ensure that policy of BMC/High Court order and statutory provisions are strictly followed. In case of violation said officer be held responsible.
- 13. All Asstt. Commissioners of respective Wards should send report regarding action taken at ward level such as granting permission / action taken against unauthorized structures / Pandals etc. to the DMC who is the Nodal Officer appointed by the Hon'ble Municipal Commissioner.
- 14. Above orders/policy is applicable for all festivals/ ceremonies of all the religions/ sects, to the places of worship of all the religions.
- 15. PRO to give publicity of grievance redress mechanism available for filing complaints regarding Noise Pollution Rules and illegal pandals/ booths on streets and footways in newspapers as well as television channels, before every major festival.
- 16. All ward Asstt. Commissioners, while granting permissions for erection of pandals/temporary booths on streets, a condition shall be imposed that "hoardings, advertisements/banners/flexes etc. shall not be displayed on the booths or in the vicinity of booths without obtaining express permission and no digging shall be made on streets, footpaths or footways without obtaining a specific permission."
- 17. All ward Asstt. Commissioners, while granting permissions for erection of pandals/temporary booths on streets, a condition shall be also imposed that applicant should comply with the noise pollution rules i.e. maintain the prescribed noise levels as laid down in the enclosed Attachment 3.

- 18. All Ward Asstt. Commissioners are directed to contact Environment Deptt. of MCGM and arrange to install / display silence zone boards in the ward. Dy.Ch.E.(Civil) Environment Deptt. is directed to supply Boards centrally and install the boards at all silence zones in co-ordination with Ward Asstt. Commissioners and E.E.(T.C.).
- 19. Ch.O.(D.M.) is directed to make necessary arrangements/ provide equipments etc. at Head Office (D.M.) Center and 24 wards (D.M.) centres, the facilities to receive complaints of noise pollution and erection of unauthorized pandals on streets through Toll Free Number, e-mail, SMS & Whats app.

Above orders will be applicable with immediate effect.

 Mixed categories of areas may be declared as one of the four above mentioned categories by the competent authority.

\*dB(A) Leq denotes the time weighted average of the level of sound in decibels on scale A which is relatable to human hearing.

A "decibel" is a unit in which noise is measured.

"A", in dB(A) Leq, denotes the frequency weighting in the measurement of noise and corresponds to frequency response characteristics of the human ear.

Leq: It is an energy mean of the noise level over a specific period.
