CIRCULAR

Subject:- Critical / dangerous bridges, signages & wardens to be provided at prominent locations, junctions & roads leading to Such critical sites in respective wards.

.....

As per Structural Audit Report of Structural Auditor, bridges which are declared as dangerous are closed by respective ward offices from safety point of view.

It is felt necessary to provide the wardens & public awareness boards on sites of critical / dangerous bridges and along the roads & junctions leading to such critical sites. Hence, following line of action is decided.

- 1) Asstt. Commissioner of ward to identify names of roads & junctions leading to critical bridge sites & provide the required public awareness boards.
- 2) Asstt. Commissioner of ward to analyze the requirement of wardens to be deployed on critical bridge sites, roads & junctions leading to critical bridge sites in consultation with traffic police.
- 3) Asstt. Commissioner of ward will inform the requirement of warden as per Sr.No.2 above to Chief Security Officer within 3 days from the date of receipt of this Circular.
- 4) Chief Security Officer will make the arrangement of warden to the respective ward offices within 7 days from the date of receipt of this Circular.
- 5) All the above arrangement has to be continued till the completion of reconstruction of critical / dangerous bridges.
- 6) The list of critical / dangerous bridges as on 18.06.2019 is attached separately.
- 7) All the above measures such as expenditure required for public awareness boards should be made from the GL Code 230801202 provided to wards and expenditure for appointment of warden should be met from the GL Code 230801603 provided to Ch. Security Officer under Revenue Budget Head under guidance of CA(Finance).

All Asst. Commissioners / Chief Security Officer are directed to follow the above directions.
