Applications are invited from eligible candidates for the vacant post of Assistant Professor in the various departments at T. N. Medical College purely on Contract Basis. Candidates who full-fill the prescribed terms and conditions mentioned in the advertisement should apply.

- 1) As per qualifications laid down by Medical Council of India / National Medical Commission for minimum qualifications for teachers in Medical Institutions Regulations 1998, as per latest amendment.
- 2) For Super Specialities DM/M.Ch./DNB and for Broad Specialities MD/MS/DNB.
- 3) All required education qualification (mark sheet & certificates), MSCIT Passing Certificate, SSC Marksheet & Passing Certificate with Marathi subject, etc. self attested photocopies should be attached with duly filled application form.
- 4) Candidate must be registered with Maharashtra Medical Council and certificate should be attached along with application form.

**WORK EXPERIENCE:**

Candidate must have completed **one year experience as Senior Resident in the concerned subject** in a recognized / approved / permitted medical college after acquiring MD / MS / DNB Degree.

Hospital and fees for application should be paid in Revenue Department of B. Y. L. Nair Ch. Hospital. **Mobile number must be quoted in the application form.**

**GENERAL CONDITIONS:**

- 1.This appointment is purely on contract basis & not on regular basis.
- 2.The contract basis appointed candidate will be discontinued at any time if not required.
- 3.The contract basis appointment will not be treated as regular appointment. Appointment will be made as per vacancies and requirements. However, Hon. Municipal Commissioner has right to cancel the selection list without giving any prior notice at any time. Being contractual post, the person appointed shall not be entitled for any other benefits applicable to regular employees and not entitled to claim any rights, interest and benefits of regular employees.
- 4.Prescribed application must be filled by candidate in his/her own handwriting and must be complete. Incomplete and unprescribed application & applications by post will not be considered.
- 5.Candidates who are in the Municipal Services must forward their application with the “No Objection Certificate” from his/her Head of the Department.
- 6.A recent passport size photo must affix in the application with his/her own signature on prescribed place.
- 7.Candidates must make sure that he/she has completed the qualifications and conditions laid down in the advertisement. Candidature can be cancelled at any time and any stage, if candidate is not fulfilling the requisite qualifications and conditions. He/She will be dismissed from the service if appointed and no correspondence will be entertained.
- 8.Address of correspondence must be clear and complete with Pin Code Number. Mobile number and e-mail address must be quoted in the application.
9. A candidate must submit their attested xerox copies of Leaving Certificate, Birth Certificate, Domicile Certificate, Aadhar Card Xerox, Pan Card Xerox, Educational Qualification Certificates, Secondary School Examination Mark List with Marathi Subject, Higher Secondary School Examination Mark List, MSCIT Certificate, Employment Qualification Certificate, Caste Certificate issued by competent authority & Caste Validity Certificate. For married female candidate Marriage Certificate, Gazette Copy of Name Change is essential. If it is not available, married female candidate can apply with their name before marriage. Candidate must furnish attested xerox copies of Undergraduate and Postgraduate examination passing certificate.
- 10.Selected candidate will be appointed at T. N. Medical College only.
- 11.Candidature can be cancelled at any stage of selection process or after selection if it is found that candidate is not fulfilling the requisite qualification prescribed for the post or in case of false information/ certificates/ papers or hiding of required information.
- 12.Candidate must remain present with their own expenses for the interview.
- 13.Candidate must submit No Objection Certificate from the previous employer if he / she is in service.
- 14.The Municipal Commissioner MCGM has right to stop selection process at any time and at any stage.
15. Appointed Candidate in not eligible for any type of leave and service quarters.
16. If the candidate appointed on contract basis desire to resign, he/she must submit resignation with a notice of one month in advance.
17. Applicants who are found not eligible will not be informed independently / individually.
18. All the selections will be made as per the MCI / NMC norms.
19. The selected candidate will have to submit legal agreement on bond paper of Rs. 500/- and have to pay necessary legal & stationary charges as per latest circular issued by legal department.
