Terms and conditions for the post to be appointed on a contract basis.

- 1) Candidate shall bear the prescribed qualification for selected posts.
- 2) Candidate appointed on a contract basis will not be able to claim for regular service of the Corporation.
- 3) The candidate, if selected will have to submit a contract agreement on bond paper of Rs. 100/- to Rs. 500/- in BMC format.
- 4) The candidate will not be given any other kind of allowance except applicable fixed remuneration.
- 5) The contract is for a specific period of 6 months and the post will be renewed based on the candidate's performance.
- 6) If the work of contractual candidates is unsatisfactory during the contract period, the appointment of such candidates on a contract basis will be terminated without any prior notice.
- 7) No administrative or financial rights of MCGM will be granted to selected candidates during the contract period.
- 8) The correspondence address should be clear and complete.
- 9) Selected candidates should be present for further selection procedure with Certificates of Educational Qualification, Professional Qualifications, Marksheets, Certificate of Experience. (original copies and attested Xerox copies.)
- 10) Candidates must be present at the place of selection at their own cost.
- 11) Candidates will be disqualified if they are found to have submitted incorrect information/certificates/documents or withheld any information at any time after the commencement of the selection process or appointment. Also, if the appointment is made, their contract appointment will be terminated without any prior notice.

- 14) As the service of the candidates working during the contract period is temporary, their service will not be considered for seniority, or the service will not be given priority for seniority.
- 15) Only online applications are considered valid and those received by post at the concerned office and other places will not be considered valid. Also, note that BMC has not given the right to any person or any other organization to sell or accept applications.
