- 1. Appointments will be made as per vacancies and requirements. However, Hon. Municipal Commissioner has right to cancel the selection list without giving any notice at any time.
- 2. The vacancies shown in the advertisement are likely to vary.
- 3. Prescribed application must be filled by candidate in his/her own handwriting and must complete. Incomplete and unprescribed applications will not considered.
- 4. Candidates who are in the Municipal Services must forward their application with the "No Objection Certificate" from his/her Head of the Department.
- 5. A recent passport size photo must affix in the application with his/her own signature on prescribed place.
- 6. Candidates must make sure that he/she is completed the qualifications and conditions. Candidature can be cancelled at any time and any stage, if candidate is not fulfilling the requisite qualifications and conditions. He/She will be dismissed from the services if appointed and no correspondence will be entertained.
- 7. Address of correspondence must be clear and complete with Pin Code Number. Telephone Number and Mobile Number with E Mail I.D. must be quoted in the application.
- 8. Candidate applying for Assistant Professor's posts should possess knowledge of Computer operating. They should have passed the "CCC" examination conducted by DOEACC Society, at "O" level or "A" level or "B" level or "C" level or "G.E.C.T. Or MSCIT conducted by the Maharashtra State Board of Higher & Technical Education, Mumbai. Their services will be terminated if he/she will not pass above stated M.S.C.I.T. Examination or G.E.C.T. Examination within two years from the date of joining.
- 9. As per the Circular No. MPM / II / 7984 dated 20.06.2016, a candidate will be passed Secondary School Certificate or equivalent OR Higher Examination with MARATHI Subject (Higher OR Lower grade) of 50 marks.
 - a) If candidate is not passed above mentioned marathi language examination at the time of their first appointment on the post of Assistant Professor, the appointment of these candidates will be made on Temporary basis for first two years subject to passing of marathi Language examination.
 - b) If candidate will not passed secondary school certificate examination with marathi language or marathi language examination conducted by MCGM before first yearly increament then they will not eligible for yearly increament. However candidate will be eligible for their yearly increament with retrospective effect, if they will pass marathi language examination within two years from the date of appointment.
 - c) If candidate will not passed secondary school certificate examination with marathi language or marathi language examination conducted by MCGM within two years from their date of appointment their services will be discontinue.
- 10. A candidate must submit their attested zerox copies of Leaving Certificate, Birth Certificate, Domicile Certificate, Educational Qualification Certificates, Secondary & Higher Secondary School Examination Mark List, Employment Qualification Certificate, Caste Certificate issued by competent authority, Cast Validity Certificate, latest Non Creamy Layer Certificate. For married female candidate Marriage Certificate, Gazette Copy of Name Change. If it is not available, married female candidate can apply with their before marriage name. Candidate must furnish attested zerox copies of Undergraduate and Postgraduate examination passing certificate if passed in more than 1st attempt.
- 11. Candidate will not eligible for the appointment if he/she punished by any court in the Civil/Criminal cases. Candidate must produce the details, if he / she facing

police inquiry/outstanding court matter or punishment if any. Selected candidate must submit N.O.C. from the police department at the time of appointment.

- 12. Selected candidate must pay the amount equivalent with the one month's pay as security deposit at the time of his/her appointment or he/she should submit the bond accordingly. The security deposit paid by the candidate will not be refundable if the appointment is not accepted by the candidate or if he/she resigned or dismissed during his/her probation period.
- 13. Selected candidate will be appointed in any Municipal Medical College /
 Hospital of Greater Mumbai Municipal jurisdiction and will be transfer, if
 required in any Municipal Medical College/ Hospital of Greater Mumbai Municipal jurisdiction.
- 14. Candidature can be cancelled at any stage of selection process or after selection if it is found that candidate is not fulfilling the requisite qualification prescribed for the post or in case of false information / certificates / papers or hiding of required information.
- 15. Selected candidate will be governed by "The Municipal Service Rules 1989 and "The Municipal Conduct and Discipline Rule 1999 as modified by time to time.
- 16. If the candidate is in municipal services from 05.05.2008 those selected candidates will be eligible for the defined contribution pension scheme from their date of appointment. They are not eligible for the existing General Provident Fund scheme as well pension scheme of M.C.G.M. i.e. M.C.G.M. Pension Rules 1953.
- 17. Selected candidate will be appointed for a probation period of 3 years. Continuation will be depends on working of candidates in probation period within 3 years.
- 18. The appointment will be made only after the receipt of police verification certificate and character certificate from the concerned police station.
- 19. Candidate must remain present with their own expenses for the interview.
