


## **ORGANIZATION CHART - ANNEXURE II**



It is an Act to provide for setting out the practical regime of right to information for citizens to secure access to information under the control of public authorities, in order to promote transparency and accountability in the working of every public authority, the constitution of a Central information, Commission and State Information Commissions and for matter connected therewith or incidental thereto.

Hence, an informative handbook containing the details of concerned organization, its function and the kind of information that can be made available by the organization is formulated for the benefit of general public.
