Subject : Regarding hiring 12 contractual workers from a non governmental organizations for the period of 01.11.2025 to 20.03.2026 (113 days or less from the date of assignment excluding public holidays and weekly holidays) to take eviction action against unauthorized hawkers & removed unauthorized posters, banners, boards in M/West Ward.

A non- government organization will be selected for hiring contract workers on the encroachment removal vehicles in M/West Ward. Applications (sealed envelope) contract are being invited from organizations which are experienced in carrying out work on such vehicles or providing workers in the other departments of the corporation, as also from interested local registered non government organizations, registered workers co-operative societies, service co-operative societies, employment co-operative societies, industrial service co-operative societies (excluding women's self- help groups, various boards and institutions currently operating in M/West Ward under Swachhdra Mumbai Prabodhan Abhiyan, Road Cleaning Scheme) etc. Organizations registered under the jurisdictions of the M/ Ward office, who have experience in working on the said vehicle or have experience in supplying labour to other departments of the Municipal Corporation, the eligibility list of the organization will be prepared and the selection will be made through lottery. A total of 12 workers are required from the selected organizations from 7.00 am to 10pm(morning and evening session or break duty) per day

The application forms will be available from the office of Senior Inspector Licence (Encroachment Removal) at M/West Ward office, Second Floor by payment of a sum of Rs. 3630 + 353.40(18% GST) totaling Rs. 4283.40 in cash (Non Refundable) from dt. 09.10.2025 to dt. 16.10.2025 on working days from 10.30 am to 01.00 pm.

The application period is forms is from dt. 09.10.2025 to dt. 16.10.2025 (excluding Sunday & Public Holiday) on working day from 10.30 am to 05.30 pm. The last date of application is 16.10.2025 up to 01.00 pm, applications (sealed envelope) submitted after the said period will not be considered.

The Assistant Commissioner, M/West Ward will allocate the work to the organization selected through lottery from the list of eligible organizations as per the criteria as per the term and conditions of the scheme. The list of eligible/non eligible organizations will not be displayed on the board. The Assistant Commissioner, M/West Ward will have the right to cancel the result of the lottery process.

The last date for submission of applications will be 16.10.2025 (up till 01.00 pm). The tender will be drawn on 17.10.2025 at 3.00 PM.
