

## Undertaking Cum Indemnity Bond

- (3) I / We state that I / We have applied for permission of the said festival / program at \_\_\_\_\_.(herein after referred to as “the said premises”).
- (4) I / We state that I / We have gone through the codified fire safety requirements of Mumbai Fire Brigade on MCGM portal to be complied in respect of the above said program & using temporary structure and I / We hereby declare that all the fire safety measures are / will be complied all the time by me / us. I / We shall not indulge into any activity which may cause fire/ health hazard and against the provisions of law.
- (5) I / We say and undertake that the electrical fittings / fixtures installed in the premises are as per The Electricity Act, 2003 and the Rules, from Govt. approved Electrical Inspector.
- (6) I / We say and undertake that as per the provisions of Section 3(3) of The Maharashtra Fire Prevention and Life Safety Measures Act, 2006 and Rule 4(1) / Rule 1(2) of the Maharashtra Fire Prevention and Life Safety Measures Rules, 2009, fire safety measures will be provided on the said premises & will be maintained in good working order.
- (7) I / We say and undertake that, if it is revealed that the codified requirements of Mumbai Fire Brigade/ requirement as per Maharashtra Fire Prevention and Life Safety Measure Act, 2006 and any competent Municipal Authority are not complied by me / us and also any unauthorised construction is/ are found carried out by me/ us, then the MCGM shall be at liberty to suspend/ revoke the aforesaid permission

with immediate effect.

- (8) I / We hereby Indemnify the MCGM from and against all actions, acts, costs, claims, damages, demands of any nature and kind whatsoever, which may be instituted, claimed or made against the MCGM, its officers, servants and agents and the Municipal Commissioner for MCGM by any person or persons, any third party or legal entity by reasons of the MCGM having granted to me / us the said permission as per Mumbai Municipal Corporation Act, 1888.
- (9) I / We are aware and accept that I / We shall be liable to civil as well as criminal prosecution in the event information submitted by me / us are found to be false and / or incorrect and permission fee/ deposit amount if any paid by me / us shall be forfeited.
- (10) I / We say and undertake that the undertaking is binding on me / us / Chairman / Secretary/Managing Committee members who are responsible for the acts done by the firm/organisation from time to time.
