Successful bidder will have to operate the Pay & Park Scheme by providing infrastructure facility at their own cost and by engaging their own staff and meeting other expenses etc. and to recover charges from the vehicle owner/driver as per rates approved by the Municipal Corporation with the help of Web based automated device known as '**Hand Held Device**'. The cost of hand held devices along with necessary software and hardware will be bear by parking agency itself.

The offer should be enclosed in Packet "A", Packet "B" and Packet "C" (Commercial Bid) respectively and super scribed with the words "**OFFER FOR running pay & park scheme** specifying location at '**Hutatma Chowk No. 3**' in 'A' Ward and submitted on the portal (<http://portal.mcgm.gov.in>). The quotationer shall have to pay 'Quotation Fee' of **Rs. 220 + 18 % GST** through online payment. E.M.D. which is payable in the form of ONLINE MODE only on due date in Packet 'A'. Packet 'B' to be submitted online otherwise the offer will be treated non responsible.

The quotationer should upload scanned digitally signed copy of the original registration certificate to get registered with MCGM for e-spot quotation process, login credentials to participate in the online bidding process before purchasing / uploading / submitting the tender copy. The spot quotationer duly filled in should be uploaded and submitted online on or before the end date of submission. 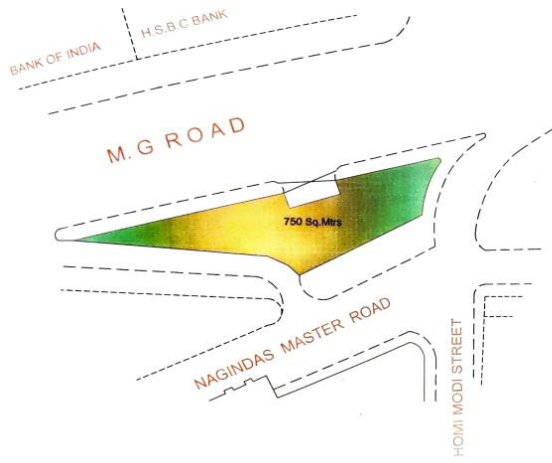
