E-SPOT QUOTATION NOTICE

Separate sealed E-spot quotations are invited for Demolition action on illegal mobile towers of in M/East ward from registered demolition contractors in MCGM.

The terms and conditions of the spot quotations are as such:

- 1) Contract period: - **1 Year.**
- 2) Before submission of the quotation the quotationer must visit the site if possible to get himself quainter with the nature of the work.
- 3) Each quotation shall be enclosed separately in tightly sealed envelope addressed to the Assistant Commissioner of M/East Ward and subscribed "Spot quotation for Demolition of unauthorized Mobile Tower in M/East ward." shall be dropped in the box made available in the office of Asstt. Engr. (Maintenance) M/East Ward, Muni. Office M.T.Kadam Marg, Durga Devi Chowk, Govandi, Mumbai-43 upto 09.11.2022 Time 1.00 p.m. only. Quotation received after this hour and date shall be returned unopened to the quotation.
- 4) The received sealed envelopes shall be opened at 03.00 pm on 09.11.2022 in cabin of D.O. (B. &.F.) M/ East ward.
- 5) The quotation for demolition of mobile tower shall be invited on the following terms & conditions:-
 - a) You shall demolish the mobile tower under reference from the receipt of this intimation letter & shall clear the site and all the material of mobile tower shall be transported at your own cost within 24 hours.
 - b) Demolition work shall be carried out under supervision and guidance of Civil engineer and safety engineer. All the safety measure shall be taken by you such as barricading etc.
 - c) If accident/ mishap shall occur you will be solely responsible for any causality/ loss of human lives (i.e. worker as well as passer by etc.) during the demolition work. Indemnity bond / Registered under taking indemnifying M.C.G.M. for above condition shall be submitted on Rs.200 stamp paper.
 - d) Demolition of mobile tower completely, moving & transporting material of entire site at your own risk & cost.
 - e) One number of mobile towers shall be removed daily by you. There shall not be any material on the road/ site. The responsibility of material of mobile tower entirely lies with you & no payment shall be paid to you for removal & transportation of material of mobile tower.
 - f) The number of mobile tower as per list may vary accordingly as mobile tower may be removed by the concerned party/ Company after notice.
- 6) All the rates shall be inclusive of all duties such as customs, excise, Octroi etc. or otherwise there actual amount should be shown extra. If it is not mentioned it will be presumed that the rates are inclusive of such duties and no subsequent claim for payment of these duties will be entertained.
- 7) Terms and payment - As per the Municipal procedure the payment will be paid after demolition of mobile tower within 7 days.
- 8) Penalty-As per the terms and conditions of G.C.C. / MCGM. For failure to execute the work within the stipulated period, a penalty equivalent to half percent per week or part thereof on the value of the work will be recovered for the contractor's bill without any reference to the contractor.
- 9) The Quotationer shall pay Rs.40000/- & above per mobile tower as per terms & conditions.
- 10) MCGM will not be held responsible for any mishap happen will carrying out demolition of mobile tower, therefore due care shall be taken by quotationer will carrying out demolition of mobile tower.
