Said 600 tenements ground will be available on 'as is where is basis'. In any care any kind of ground improvement shall not be done by MCGM.

Successful bidder will have to operate the Pay & Park Scheme by Providing infrastructure facility at their own cost and by engaging their own staff and meeting other expenses etc and to recover charges from the vehicle owner/driver as per rates approved by the Municipal Corporation.

Offer containing erasures or alterations not so attested or written in illegible form are liable to be rejected. The offer shall be firm and no variation will be allowed on any account.
- 7. Offer must be submitted in the same form that is issued to the bidder and not in a copy there of.
- 8. The bidder is requested to produce along with this offer the attested photo copies of income-Tax "Pan" Card not below the rank of Gazetted officer or officer not below the rank of Asst. Engineer of MCGM, without this, his offer will be rejected.

#### 9. <u>Bidder will have to pay EMD-10% i.e. Rs. 40,500.00/-</u> of the contract cost <u>Rs.</u> <u>4,04,978.00/-</u> only in favour of MCGM.

- 10. It is optional to the contractor to make the contract deposit as in form of Demand Draft/Pay order. If the offer of the 1<sup>st</sup> Highest bidder is accepted by the M.C.G.M. but, for one or the other reason if bidder does not respond for the same, the bidder with be debarred from participation in future for Pay & Park contract schemes invited during next Three (3) Years.
- 11. Successful bidder shall require to execute the contract within seven days of the receipt of the intimation to execute the contract, Failing to execute contract within specified period from receipt of contract documents shall be deemed to have committed a breach of the undertaking given by them in their offer, and the Municipal Commissioner may forfeit the E.M.D. The bidders will also be debarred from participation in future Pay & Park schemes invited during next Three (3) years.
- 12. The successful bidder shall take over possession of the site and start running site within one week from the date of receipt of the acceptance letter/allotment letter after completing all formalities mentioned in above.
- 13. The successful bidder at his (their) own cost enter into written agreement with the Corporation to be drafted by Law Officer of the Corporation embodying such further cost incidentals to the preparation of the agreement including stamp duty and all

other expenses shall be borne by the bidder.

## 14. The Commissioner does not bind himself to accept the highest or other offers.

- 15. Offer documents are not transferable.
- 16. In the event of dispute the Municipal Corporation of Greater Mumbai and the Contractor, the dispute would be subject to the jurisdiction to the courts in Mumbai.
- 17. If any bidder does not fulfil the mandatory condition stated in the offer documents his offer will be rejected.
- 18. The successful bidder should carefully follow all the terms & condition of the contract as per appendix 'B'.
