The Brihanmumbai Municipal Corporation (BMC) invites-tender on **Item Rate / Percentage Rate** basis to appoint Contractor for the aforementioned work from Manufacturers / Authorized dealers / Contractors who are dealing with such type work. The contractors who are not registered with BMC will have to apply for registering their firm within three months’ time period from the award of contract, otherwise their Bid Security i.e. **E.M.D** (Earnest Money Deposit) **will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.** Bidding Process will comprise of THREE stages.
