1.1 Technical Capacity

- i) The tenderer(s) / bidder(s) in their own name should have satisfactorily executed the work of similar nature in BMC / Semi Govt. / Govt. & Public Sector Organizations during last seven (7) years ending lst day of month previous to the one in which bids are invited, as a prime Contractor (or as a nominated sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied).
 - a) Three similar completed works each of value not less than Rs. 35.40 Lakh
 Or
 - b) Two similar completed works each of value not less than Rs. 41.30 Lakh
 Or
 - c) One similar completed work of value equal and or not less than Rs. 58.90 Lakh.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

- ii) Documentary proof of Work Orders & performance certificates should be submitted for the same, along with tender. Past performance certificates in respect of above should have to be issued from the officer not below the rank of Executive Engineer and shall be uploaded along with tender bid by the bidder while submitting the Bid. All the above experience shall be considered from the date of completion till due date of this tender.
 - iii) The bidder shall be Manufacturer itself or their Authorized Dealer/distributor or representative appointed by manufacturer for the subject work who will obtain Manufacturer authorization letter in the format given in Annexure-H duly filled, signed and sealed by authorized person of the manufacturer. This authorization letter must be accompanied with the tender failing which the tender /offer shall be out rightly rejected.

1.2 Financial Capacity

Achieved an average annual financial turnover as certified by "Chartered Accountant" (in all classes of civil engineering construction works only) equal to Rs. 35.40 Lakh in last three (3) financial years (i.e. 2019-20, 2020-21 & 2021-22) immediately preceding the Financial Year in which bids are invited.
