The Brihanmumbai Municipal Corporation (BMC) invites e-tender on item rate / Percentage Rate Basis to appoint BMC registered Contractor for the aforementioned work from Contractors who are dealing with such type work. The contractors who are not registered with BMC will have to apply for registering their firm within three months time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.

Bidding Process will comprise of THREE stages.

The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for etendering process & obtain login credentials to participate in the online bidding process.

- ii) Followed by SRM login ID and password to be obtained from Central Purchase Department (CPD), Office at Byculla, Bakariadda, Mumbai
- iii) For e-Tendering registration, enrollment for digital signature certificates and user manual, please refer to respective links provided in 'Tenders' tab. Vendors can get digital signature from any one of the Certifying Authorities (CA's) licensed by controller of certifying authorities namely, Safes crypt, IDRBT, National informatics center, TCS, CUSTOMS, MTNL, GNFC and e- Mudhra

1.1 Technical Capacity

The tenderer(s) in their own name should have satisfactorily executed the work of similar nature BMC /Semi Govt. /Govt. & Public Sector Organizations during last seven (7) years ending last day of month previous to the one in which bids are invited as a prime Contractor.

Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which tenders are invited should be either of the following

a) Three similar completed works each of value not less than Rs. 5,25,800/-

Or

b) Two similar completed works each of value not less than Rs. 6,13,400/-

Or

c) One similar completed work of value equal and or not less than Rs. 8,76,300/-

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

1.2 Financial Capacity

Achieved an average annual financial turnover as certified by 'Chartered Accountant' equal to **Rs. 5,25,800/-** of the estimated cost of work in last three (3) financial years immediately preceding the Financial Year in which bids are invited.

1.3 Similar Experience:

The completed or ongoing works such as replacement of control valves of sizes 900 mm dia & above / replacements of adaptor of size 900 mm dia & above in water supply networks etc. in BMC / Semi Govt. / Govt. & Public Sector Organizations.

Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have:

- made misleading or false representation in the forms, statements and attachments submitted in proof of the qualification requirements; and/or
- Record for poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc
