# Subject : Supply of portable welding machines for MSEOC section under AEOC(TM) division.

Bidding Process will comprise of THREE stages.

ii) Followed by SRM login ID and password to be obtained from Central Purchase Department (CPD), Office at Byculla, Bakariadda, Mumbai

iii) For e-Tendering registration, enrollment for digital signature certificates and user manual, please refer to respective links provided in 'Tenders' tab. Vendors can get digital signature from any one of the Certifying Authorities (CA's) licensed by controller of certifying authorities namely, Safes crypt, IDRBT, National informatics center, TCS, CUSTOMS, MTNL, GNFC and e- Mudhra

The Packet C shall be opened if bids submission in Packet A& B satisfies / includes all the requirements and same are found acceptable to the Authority.

#### **1.1 Technical Capacity**

The tenderer(s) in their own name should have satisfactorily executed the work of similar nature MCGM /Semi Govt. /Govt. & Public Sector Organizations during **last seven (7) years** ending last day of month previous to the one in which bids are invited as a prime Contractor (<del>or</del> as a nominated sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied)

The tenderer shall be Manufacturer of welding machines or their authorized dealers / distributors, authorized by Manufacturer, should have satisfactorily supplied the welding machineries. In case of dealer/ distributor, the tenderer must submit authorization letter from the manufacturer.

a) Three similar completed works each of value not less than Rs. 2,76,000/-

Or

b) Two similar completed works each of value not less than Rs. 3,22,000/-

Or

c) One similar completed work of value equal and or not less than Rs. 4,59,000/-

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

### **1.2 Financial Capacity**

Achieved an average annual financial turnover as certified by 'Chartered Accountant' equal to **Rs.2,76,000/-** of the estimated cost of work in last three (3) financial years immediately preceding the Financial Year in which bids are invited.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

## 1.3 Similar Experience:

The tenderer should have satisfactorily supplied the welding machineries.
