The similar experience should be in demolition and dismantling as per scope of work but similar experience mentioned in tender document i.e. Similar work shall mean, the completed or ongoing works in Building Construction OR Building Maintenance such as repairs/retrofitting /structural repairs OR construction/repairs Asphalt/ Concrete roads OR laying/rehabilitation of sewer lines along with allied components OR laying/rehabilitation of water pipe lines in Cast Iron/ M.S. pipes / HDPE/ MDPE pipes OR repairs/maintenance/ construction of culverts over nullah.

This tender comes is Regular, Routine and Maintenance works, So in similar experience exclusive experience of demolition and dismantling can not be considered. However, At pg. no. 11 & 27 of tender document, type of work included in Regular, Routine and Maintenance works is mentioned, which includes demolition works in building maintenance. Hence, as per scope of work demolition work along with all other mentioned works is already included in Similar experience.
