During prebid meeting, following points are raised by firms and minutes are as follows.

	A) Points raised by M/s. Mak Environtech & Solutions (India) Pvt. Ltd :	
1)	As per tender condition , the containers are to be delivered in the ward and the road side collection point. Our request is to allow us to deliver the containers at a single point. The transportation in Mumbai is real challenge and delivering each container at the collection point is too difficult in Mumbai due to narrow lanes, metro and other infrastructure works.	Please refer the tender SECTION10, SPECIFICATION: 8 – Delivery Details. Tender condition prevails.

2)	The 95% payment will be paid and 5% will be released after the completion of warranty period. Our request is to release entire 100% payment towards supply as 5% contract deposit will be already with you. Moreover this 5% amount will be blocked and which will affect our cash flow inversely.	Please refer the tender SECTION10, SPECIFICATION: 9 - Payment . Tender condition prevails.
3)	As per our experience the 10% of the amount is blocked due to pending of vigilance clearance. There is no specific time is mentioned about the clearance from vigilance department. This will also affect our cash flow. We request to release our 100% against the supply of material.	Please refer the tender SECTION10, SPECIFICATION: 9 - Payment . Tender condition prevails.
4)	The delivery period mentioned is too short we request to give additional 15 days for every point of delivery schedule.	No Change in delivery schedule. Please refer the tender SECTION 10, SPECIFICATION: 8 – Delivery Details .
5)	The weight of Lid mentioned in the tender is too high and we request to reduce it to 2 kg per lid.	Tender condition prevails.

2)	<p>In Specification point 9 payment – <u>The contractor shall raise the invoice against the supply of a minimum 75 number of containers against the Purchase Order.95% of the bill will be paid after the supply of containers against the raised invoice and remaining- 5% will be paid against satisfactory completion of work or completion of one –year warranty period, whichever is later.</u> As per tender condition, successful bidder shall submit a security deposit of 5% of contract value and as per your tender successful bidder submit SD and 5% withheld from running bills. Successful bidder was totally 10% given to BMC in the from of various deposits, which was not workable.</p>	Please refer the tender SECTION10, SPECIFICATION: 9 - Payment . Tender condition prevails.
