Subject: The work of refurbishing & overhauling of hydraulically operated Mini Excavator (TMX-20) machine and providing services of comprehensive operation and maintenance of its for desilting/cleaning of various nallas & outfalls in City, Eastern and Western Suburbs for the period of 1 year - (01 No.)

The Brihanmumbai Municipal Corporation (BMC) invites e-tender to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013 , the contractors registered with the Brihanmumbai Municipal Corporation (BMC) under category Mechanical /Electrical , Class 'B' (as per registration rules 2015) and Class 'B' (as per new registration rules, 2016) and from the contractors/firms registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three month's time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty. Bidding Process will comprise of THREE stages.

The application form can be downloaded from BMC's portal (<http://portal.mcgm.gov.in>) on payment of Rs.2,600.00 (Extra GST 18% i.e CGST 9% and SGST 9%) for each bid. Tender fee is non-refundable. The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process & obtain login credentials to participate in the online bidding process.

i) To download the application form, for those applicants not having vendor registration, need to apply first for vendor registration at the office of Account Officer (FAR), 3rd floor, Municipal Headquarter.

ii) Followed by SRM login ID and password to be obtained from Central Purchase Department (CPD), Office at Byculla, Bakariadda, Mumbai.

iii) For e-Tendering registration, enrolment for digital signature certificates and user manual, please refer to respective links provided in 'Tenders' tab. Vendors can get digital signature from any one of the Certifying Authorities (CA's) licensed by controller of certifying authorities namely, Safes crypt, IDRBT, National informatics centre, TCS, CUSTOMS, MTNL, GNFC and e-Mudhra CA.

The Bid Security of successful Bidder will be discharged when the Bidder has signed the Agreement and furnished Security Deposits. The Bidders will have to provide Earnest Money Deposit through the payment gateways while submitting the bids. The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit. The e-Tender is available on BMC portal (<http://portal.mcgm.gov.in>) as mentioned in the Header Data of the tender.

As per THREE Packet systems, the document for Packet 'A' & 'B' is to be uploaded by the bidder in vendors' document online in Packet A, B. Packet 'A', 'B' & 'C' shall be opened on dates as mentioned in header data. All the responsive and eligible bidders if they so wish can be present at the time of opening of bids, in the office of **Dy. Chief Engineer(O&M)S.W.D.** The Packet 'C' shall be opened if bids submission in Packet 'A' & 'B' satisfies/includes all the requirements and same are found acceptable to the Authority.

SECTION 2

ELIGIBILITY CRITERIA

A) Technical Capability:

a) The tenderer(s) in their own name shall have satisfactorily executed the work of similar nature in BMC /Semi Govt. /Govt. & Public Sector Organizations during **last seven (7) years** ending last day of month previous to the one in which bids are invited as a Prime Contractor (or as a nominated Sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied)

1) Three similar completed works each of value not less than Rs. 4.73 Lakhs.

OR

2) Two similar completed works each of value not less than Rs. 5.91 Lakhs.

OR

3) One similar completed work of value equal and or not less than Rs. 9.45 Lakhs.

The Bidder shall submit the certificate of satisfactory completion of work from the user Department of BMC / Semi Govt. / Govt. / Public sector organization, failing which their offer shall be treated as non-responsive and their Packet 'C' shall not be opened.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

b) The tenderer shall submit/upload authorization letter from the manufacturer of the existing hydraulically operated Mini Excavator (TMX-20) machine or authorise dealer for spare parts of the existing hydraulically operated Mini Excavator (TMX-20) machine.

B) Financial Capacity:

Achieved an average annual financial turnover as certified by 'Chartered Accountant' equal to or minimum Rs. 7.09 Lakhs for last 3 financial years. To ascertain this, tenderer(s) shall furnish / upload the financial statement (Audited balance sheet) duly certified by Chartered Accountant. The turnover can be enhanced by 10% every year to bring the present level.

C) Similar Experience:

For assessing the technical capacity of Regular, Routine and Maintenance works; similar work shall mean, the completed or ongoing works of Operation and Maintenance of hydraulic machines in BMC/Semi Govt./ Govt./ Public sector organization.
