The Brihanmumbai Municipal Corporation (BMC) invites e-tender to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' Act 2013, the contractors registered with the Brihanmumbai Municipal Corporation, (BMC) in **Class II & Above as per Registration Rules 2016 of BMC** (Excluding those who are black-listed or against whom FIR have been filed) and from the contractors/firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three months time period from the date of issue of work order failing which a penalty of 0.1% of contract cost OR Rs. 10,000/-whichever is more will be recovered/deducted from the contractors payment / bill by the department. The contractor, who fails to get registered with BMC, shall not be considered for BMC work in future in that discipline.

Bidding Process will comprise of THREE stages.

The application form can be downloaded from BMC's portal (http://portal.mcgm.gov.in) on payment of **Rs. 10,400/- plus applicable GST.** The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process & obtain login credentials to participate in the online bidding process.

 To download the application form, for those applicants not having vendor registration, need to apply first for vendor registration at the office of Account Officer (FAR), 3rd floor, Municipal Headquarter.
