SECTION 2 ELIGIBILITY CRITERIA

A)<u>Technical Capability:</u>

a) The tenderer(s) in their own name shall have satisfactorily executed the work of similar nature in BMC /Semi Govt. /Govt. & Public Sector Organizations during **last seven (7) years** ending last day of month previous to the one in which bids are invited as a Prime Contractor (or as a nominated Sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied)

1) Three similar completed works each of value not less than Rs.3.15 lakhs.

OR

2) Two similar completed works each of value not less than Rs.3.94 lakhs.

OR

3) One similar completed work of value equal and or not less than Rs. 6.30 lakhs.

The Bidder shall submit the certificate of satisfactory completion of work from the user Department of MCGM / Semi Govt. / Govt. / Public sector organization, failing which their offer shall be treated as non-responsive and their Packet 'C' shall not be opened.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

B)Financial Capacity:

Achieved an average annual financial turnover as certified by 'Chartered Accountant' equal to or minimum **Rs.4.73** lakhs for last 3 financial years. To ascertain this, tenderer (s) shall furnish /upload the financial statement (Audited balance sheet) duly certified by Chartered Accountant.The turnover can be enhanced by 10% every year to bring the present level.

C) <u>Similar Experience</u>:

For assessing the technical capacity of Regular, Routine and Maintenance works; similar work shall mean, the completed or ongoing work; on site fabrication and replacement of M.S. cover on SWD/sewer networks.
