### Name of Work: "Beautification of area below Sakinaka Metro Station in L ward under Mumbai Beautification Mission"

Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three months time period from the date of issue of work order failing which their Bid Security i.e. E.M.D. (Earnest Money Deposit) will be forfeited / recovered and a penalty of 0.1% of contract cost OR Rs. 10,000/- whichever is more will be recovered/deducted from the contractors payment / bill by the department. The contractor, who fails to get registered with BMC, shall not be considered for BMC work in future in that discipline.

Bidding Process will comprise of THREE stages.
