The BRIHANMUMBAI MUNICIPAL CORPORATION (BMC) invites e-tender on Item Rate / Percentage Rate Basis to appoint Contractor for the aforementioned work from firm who are dealing with such type work. The tenderer(s) in their own name should have satisfactorily executed the work of similar nature in BMC / Semi Govt. / Govt. & Public Sector Organizations during last Seven (7) years ending last day of month previous to the one in which bids are invited as a prime Contractor (or as a nominated sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied).
