The Brihanmumbai Municipal Corporation (BMC) invites e-tender on **Item Rate / Percentage Rate** Basis to appoint Contractor for the aforementioned work from **Manufacturers / Authorized dealers / Contractors who are dealing with similar type of works**. The contractors who are not registered with BMC will have to apply for registering their firm within three months time period from the award of contract, otherwise their Bid Security i.e. **E.M.D** (Earnest Money Deposit) **will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.**

Bidding Process will comprise of THREE stages.

The application form can be downloaded from Maha Govt.'s portal (<https://mahatenders.gov.in>) As per circular u/No.CA/FRG/03;Dtd.11.05.2023, scrutiny fee payment of **Rs. 3,894/- (3,300/- + 18% GST i.e. 594/-)** is payable through Challan at CFC Counter after opening of Packet 'A' & 'B' and before opening of Packet 'C'.

The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process & obtain login credentials to participate in the online bidding process.

i) To download the application form, for those applicants not having vendor registration, need to apply first for vendor registration at the office of Account Officer (FAR), 3rd floor, Municipal Headquarter.

The tenderer(s) in their own name should have satisfactorily executed the work of similar nature in BMC / Semi Govt. / Govt. & Public Sector Organizations during last Seven (7) years ending last day of month previous to the one in which bids are invited as a prime Contractor ~~(or as a nominated sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied).~~

**(i)** The bidder shall be **Manufacturer and or an Authorized Dealer** of the Manufacturer for Butterfly valves. If tenderer is authorized dealer then he shall produce authorisation certificate from Manufacturer on Manufacturer's Letter head in the format given in annexure-G (Pg. 183).

**(ii)** The bidder shall visit the site of works to get aware with work. They shall submit the undertaking in the format attached as "Undertaking for site visit" (Pg.184) sign by BMC Engineer at the time of site visit. While submitting the tender attach the above format signed by BMC Engineer failing which the tender shall be out rightly rejected.

(iii) The bidder shall submit proof of design from the Manufacturer of butterfly valves which has offered in bid.

(iv) Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which tenders are invited should be either of the following

a) **Three similar completed works each of value not less than Rs 6.30 Lakhs**

**OR**

b) **Two similar completed works each of value not less than Rs 7.30 Lakhs**

**OR**

c) **One similar completed work of value equal and or not less than Rs 10.40 Lakhs**

*The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.*

### **1.2 Financial Capacity :**

Achieved an average annual financial turnover as certified by "Chartered Accountant" equal to **Rs 6.30 Lakhs** of work in **last three (3) financial years (i.e. 2021-22, 2022-23 & 2023-24)** immediately preceding the Financial Year in which bids are invited.
