The Brihanmumbai Municipal Corporation (BMC) invites e-tender for the aforementioned supply from contractors of repute, multi disciplinary engineering organizations i.e. eminent firm or Proprietary/Partnership Firms or ( Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013) the contractors registered with Brihanmumbai Municipal Corporation, (BMC) will be allowed.

Bidding Process will comprise of THREE stages.

The application form can be downloaded from BMC's portal (<https://mahatenders.gov.in/>). The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process & obtain login credentials to participate in the online bidding process.

i) To download the application form, for those applicants not having vendor registration, need to apply first for vendor registration at the office of Account Officer (FAR), 3rd floor, Municipal Headquarter.

ii) For e-Tendering registration, enrolment for digital signature certificates and user manual, please refer to respective links provided in 'Tenders' tab. Vendors can get digital signature from any one of the Certifying Authorities (CA's) licensed by controller of certifying authorities namely, Safes crypt, IDRBT, National informatics center, TCS, CUSTOMS, MTNL, GNFC and e- Mudhra CA.

In terms of the 3-stage system of e-tendering, a Bidder will be required to deposit, along with its Bid, an Earnest Money Deposit of **Rs. 9,800/- (Nine Thousand Eight Hundred Only)** (the "EMD"), refundable in accordance to the relevant clause of bid document, from the Bid Due Date, except in the case of the selected Bidder whose Bid Security/EMD shall be retained.
