#### E-TENDER NOTICE

<u>Subject</u>: The work of Electrical Insulation arrangement at Ghatkopar Meter Workshop under AE(MW)ES

The Brihanmumbai Municipal Corporation (BMC) invites e-tender on <a href="Item Rate">Item Rate</a> / <a href="Percentage Rate">Percentage Rate</a> Basis to appoint Contractor for the aforementioned work from Manufacturers / <a href="Authorized dealers">Authorized dealers</a> / <a href="Contractors">Contractors</a> of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013 who are dealing with similar type of works, and registered with Brihanmumbai Municipal Corporation (BMC) in Class 'D' as per old registration and Class 'B' as per new registration in Mechanical & Electrical category or from the contractors/firms equivalent or superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three months time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.

Bidding Process will comprise of THREE stages.

The applicant has to pay Scrutiny Fee of **Rs. 3,894.00 (3,300.00 + 18 % GST)** (As per Circular No. CA/FRG/03/dt.11.05.2023). As per Circular No. CA/FRG/18 dt. 27.02.2024 scrutiny fees including applicable GST shall be paid after opening of packet A and before opening of packet C only in any CFC of BMC by Challan. Scrutiny Fee is non refundable.

- i. The forms of Tender documents are available on the e-Tendering website https://mahatenders.gov.in. The aspiring Applicants will have to download Tender form, from the website mentioned above. The bidder has to fill in online format and upload information regarding Tender Online. Also, he has to download the Tender application form from website, fill it and upload the scanned copy of duly filled form, along with required documents.
- ii. For purchasing the Tender documents, the bidders will have to get registered with e-tender portal (https://mahatenders.gov.in) for the e-tendering process and obtain login credentials to participate in the online Tender process. The details of the same are available on https://mahatenders.gov.in. For registration, enrolment for digital signature certificates and user manual, please refer to respective links provided in e-tendering tab on https://mahatenders.gov.in.

In terms of the 3 stage system of e-tendering, a Bidder will be required to deposit, along with its Bid, an **Earnest Money Deposit** of **Rs. 22,100**/- (Rupees Twenty Two Thousand One Hundred only) to be paid online only before the due date & time of the tender, as per the circular u/no CA/ Finance/ Project/ 19 dated 04.03.2024) the "EMD", refundable in accordance to the relevant clause of bid document, from the Bid Due Date, except in the case of the selected Bidder whose Bid Security/EMD shall be retained. The Bidders will have to provide Earnest Money Deposit through the payment gateways while submitting the bids. The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit. The e-tender is available on Maha Govt.'s portal (https://mahatenders.gov.in) as mentioned in the Header Data of the tender.

As per THREE Packet systems, the document for Packet A & B is to be uploaded by the bidder in vendor's document online in Packet A, B. The Packet A, B & C shall be opened on dates as mentioned in header data. All the responsive and eligible bidders if they so wish can be present at the time of opening of bids, in the office of Assistant Engineer (Meter Workshop)E/S. The Packet C shall be opened if bids submission in Packet A & B satisfies/includes all the requirements and same are found acceptable to the Authority.

The Municipal Commissioner reserves the right to reject all or any of the e- tender(s) without assigning any reasons at any stage.

The dates and time for submission and opening the bids are as shown in the Header Data. If there are any changes in the dates the same will be displayed on the Maha Govt.'s portal. (<a href="https://mahatenders.gov.in">https://mahatenders.gov.in</a>)



# 1.1 Technical Capacity

(i) The tenderer/bidder in their own name should have satisfactorily executed the work of Similar Nature in BMC/Semi Government/ Government/ Public Sector Undertakings, during last seven (7) years ending last day of month previous to the one in which bids are invited, as stated below –

Three similar completed works each of value not less than Rs. 6,60,033.00 OR

Two similar completed works each of value not less than Rs. 7,70,038.50 OR

One similar completed work of value equal and or not less than Rs. 11,00,055.00

The value of completed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

- (ii) Documentary proof of Work Orders & performance certificates should be submitted for same, along with tender, failing which tenders bid shall be rejected out rightly. Past performance certificates in respect of above should be issued from the officer not below the rank of Executive Engineer or equivalent and shall be uploaded along with tender bid by the bidder while submitting the Bid. All the above experience shall be considered from the date of completion till due date of this tender.
- (iii) The bidder shall be registered contractor in Mechanical / Electrical category in BMC in Class D as per old registration or Class B as per new registration. If the bidder is not registered in BMC, they have to submit the notarized undertaking on Rs 500/- Stamp paper with Packet 'B that "they will apply for registering their firm within three months time period from the award of contract", otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration fee of respective class will be recovered as penalty.
- (iv) The lowest bidder shall submit the test certificate for material by ERDA approved on letterhead of Manufacturer.
- (v) The bidder shall visit the site of work ie. Ghatkopar Meter Workshop with their engineers along with concerned BMC Engineer, before bidding on this work to get aware with work. They shall submit the undertaking with sign of BMC engineer who accompanied the bidder during their site visit in the format attached as "Undertaking for site visit" (Pg127) while submitting the tender failing which the tender shall be out rightly rejected.
- vi) The tenderer shall submit Manufacturer's authorization on letterhead of Manufacture in the format given at Pg C/128, duly filled, signed and sealed by Authorized person of the OEM. This authorization letter must be accompanied with the tender, failing which the tender / offer shall be out rightly rejected.

### 1.2 Financial Capacity

The bidder should have achieved an average annual financial turnover, as certified and/or audited by 'Chartered Accountant', of **Rs.** 6,60,033/- or above, during the last 03 (Three) Financial Year i.e. **FY2021-22**, 2022-23 & 2023-24.

# 1.3 Similar Experience:

For assessing the technical capacity of Regular, Routine and Maintenance works; Similar work shall mean, the completed or ongoing works such as, "Electrical insulation epoxy floor coating or any type of epoxy coating works." The tenderer shall submit the work orders / certificates for such similar

type of works for the last seven (7) years ending last day of month previous to the one in which bids are invited".

# 1.4 Bid Capacity: Not Applicable for M & E works

The bid capacity of the prospective bidders will be calculated as under: Assessed Available Bid Capacity = (A\*N\*2-B)

Where,

A = Maximum value of Civil Engineering works executed in any one year (year means Financial year) during the last five years (updated to the price level of the Financial year in which bids are received at a rate of 10% per year) taking into account the completed as well as works in progress.

N = Number of years prescribed for completion of the Project/Works, Including monsoon period, for which these bids are being invited. (E.g. 7 months = 7/12 year) For every intervening monsoon 0.33 shall be added to N.

**B** – Value of existing commitments (only allotted works) on the last date of submission of bids as per bidding document and on going works to be completed during the period of completion of the Project/Works for which these bids are being invited.

Note: The statement showing the value of existing commitments and on going works as well as the stipulated period of completion remaining for each of the works listed should be attached along with certificates duly signed by the Engineer in Charge, not below the rank of an Executive Engineer or equivalent.

# Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have:

- made misleading or false representation in the forms, statements and attachments submitted in proof of the qualification requirements; and/or
- Record for poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.
