The Brihanmumbai Municipal Corporation (BMC) invites e-tender on item rate basis to appoint Contractor for the aforementioned work from contractors of reputed, multidisciplinary engineering organizations i.e. eminent firm, Proprietary / Partnership Firms / Private Limited Companies / Public Limited Companies / Companies registered under the Indian companies act 2013, the contractors registered with the Brihanmumbai Municipal Corporation (BMC) in **Class 'C' as per new registration in Either Mechanical or Electrical category and from the contractors / firms equivalent and superior classes registered in Central or State Government / Semi Govt.
