The Brihan Mumbai Municipal Corporation (BMC) invites e-tender on **Item Rate / Percentage Rate** Basis to appoint Bidder for the aforementioned work. BMC scheduled registered bidders in electrical /mechanical category of BMC class 'A' or above and with similar or higher class of public sector or Govt. or Semi Govt. organization OR Registered bidders in public sector or Govt. or semi Govt. organization.

The bidder shall be either manufacturer of various accessories required for minimum 6 Kg/Hr capacity Electro Chlorination Plant i.e. (Electrolyzer Cell and allied accessories) OR The Bidder shall have successfully executed work of SITC of various accessories required for minimum 6 Kg/Hr capacity Electro Chlorination Plant i.e. (Electrolyzer Cell/ Chiller unit / Rectifier Units/ Brine Pumps/ Hypo dosing pumps) in Government Organization, Semi-Government, BMC or Public Sector during last seven (7) years ending last date of month previous to the one in which bids are invited as a prime contractor. Documentary proof of Work / performance certificate and plant capacities should be furnished for same.

The bidders who are not registered with BMC will have to apply for registering their firm within three months time period from the award of contract, otherwise their Bid Security i.e. **E.M.D** (Earnest Money Deposit) **will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.**

Bidding Process will comprise of THREE stages.
