Bidding Process will comprise of THREE stages.

If the work is allotted to the contractors who is not registered with B.M.C. (in same class, equivalent to BMC) within three month from date of issue of work order otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited / recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.

1.2 Financial Capacity

The Bidder shall have achieved an average annual financial turnover as certified by Chartered Accountant equal to 30% of the estimated cost in last (3) financial years immediately preceding the financial year in which bids are invited. i.e. **Rs 2,66,640/-**

The value of each year's turnover shall be brought to current costing level by enhancing the actual value at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

1.3 Similar Experience:

"Similar work shall mean, the bidder shall have carried out work in the field of Supply, Installation, Testing & Commissioning of Personal Computers, Printers, Scanners and/or other electronic hardware peripherals such as LAPTOP, Servers, Hard Disks, RAM, Biometric TAB in BMC/for any Government / Semi-Government Organizations / Public Sector Undertakings.

Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they:

- Have made misleading or false representation in the forms, statements and attachments submitted in proof of the qualification requirements; and/or
- Have record for poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, or financial failures etc.
