This is an E-Tender notice. The Brihanmumbai Municipal Corporation invites the following online tenders. The e-Tender copy can be downloaded from mahatenders portal (<https://mahatenders.gov.in>) under “e-procurement” section.

All interested bidders i.e. fulfilling the specified eligibility criteria, whether already registered or not registered in BMC, are mandated to get registered with BMC for e-tendering process, Login Credentials to participate in the online bidding process on the above-mentioned portal under “e-procurement”.

For registration, enrollment for digital signature certificate & user manual, please refer to respective links provided in e-tendering tab on BMC website. The bidders can get digital signature from any one of the Certifying Authorities (CA’s) licensed by the controller of Certifying Authorities namely Safes crypt, IDRBT, National Informatics Centre, TCS, Customs, MTNL, GNFC and e-Mudhra CA.

BMC has opened a help desk at the LTMG Hospital Assistant Engg (M&E)’s office to help the bidders in this regard.

Eligibility Criteria for bid No.1 is as follows:

1. Class ' B1 ' in Mechanical & electrical category as per new registration rules 2016.
2. The tenderer(s) in their own name should have satisfactorily executed the work of similar nature MCGM/Semi Govt. /Govt. & Public Sector Organizations during last seven (7) years ending last day of month previous to the one in which bids are invited as a prime Contractor (or as a nominated sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied)

a) Three similar completed works each of value not less than the value equal to estimated cost put to tender i.e Rs.1.39 Lacs OR

b) Two similar completed works each of value not less than the value equal to estimated cost put to tender i.e Rs. 1.73 Lacs

OR

c) One similar completed work of value equal & or not less than the value equal to estimated cost put to tender i.e. Rs. 2.77 Lacs

The tenderer shall be either manufacturer of AFP Ball OR their authorized dealer /distributor who obtain back up guarantee from manufacturer of the tendered product, failing which the offer will be considered as Non –responsive offer.

The free demo shall be arranged by contractor as per the requirement of this section for any numbers of times during defect liability period.

Documents of compliance of above criteria shall be uploaded during the submission of the tender.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

Note: The statement showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be attached along with certificates duly signed by the Engineer-in Charge, not below the rank of an Executive Engineer or equivalent.

Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have:

- Made misleading or false representation in the forms, statements and attachments submitted in proof of the qualification requirements; and/or
- Record for poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.
