This is an E-Tender notice. The Brihanmumbai Municipal Corporation invites the following online tenders. The e-Tender copy can be downloaded from mahatenders portal (<https://mahatenders.gov.in>) under “e-procurement” section.

All interested bidders i.e. fulfilling the specified eligibility criteria, whether already registered or not registered in BMC, are mandated to get registered with BMC for e-tendering process, Login Credentials to participate in the online bidding process on the above-mentioned portal under “e-procurement”.

The bidders can get digital signature from any one of the Certifying Authorities (CA’s) licensed by the controller of Certifying Authorities namely Safes crypt, IDRBT, National Informatics Centre, TCS, Customs, MTNL, GNFC and e-Mudhra CA.

1. Class ' B ' & / OR above as per new registration of Year 2016 in Either Mechanical or Electrical category.
2. The tenderer(s) in their own name should have satisfactorily executed the work of similar nature MCGM/Semi Govt. /Govt. & Public Sector Organizations during last seven (7) years ending last day of month previous to the one in which bids are invited as a prime Contractor (or as a nominated sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied)
  - a) Three similar completed works each of value not less than the value equal to estimated cost put to tender i.e Rs. 4.83 Lakh OR
  - b) Two similar completed works each of value not less than the value equal to estimated cost put to tender i.e Rs. 6.04 Lakh OR
  - c) One similar completed work of value equal & or not less than the value equal to estimated cost put to tender i.e Rs. 9.67 Lakh

In case of similar shall mean the satisfactorily completed SITC/Repair of Hospital equipment.

The Bidder must be an Original Equipment Manufacturer or must be having an authorization letter by an OEM for Sr. No. 3

The tenderer(s) in their own name should have satisfactorily executed the work of similar nature MCGM/Semi Govt. /Govt. & Public Sector Organizations during last seven (7) years ending last day of month previous to the one in which bids are invited as a prime Contractor (or as a nominated sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied)
  - a) Three similar completed works each of value not less than the value equal to estimated cost put to tender i.e. Rs. 1.44 Lac OR
  - b) Two similar completed works each of value not less than the value equal to estimated cost put to tender i.e. Rs. 1.80 Lac OR
  - c) One similar completed work of value equal and or not less than the value equal to estimated cost put to tender i.e. Rs. 2.88 Lac

The tenderer must have experience of facility management work at hospitals/ CMC / AMC / Repairs of Hospital equipment's failing which the offer will be considered as Non –responsive offer.

Documents of compliance of above criteria shall be uploaded during the submission of the tender.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.
