Sub:-Deployment of Watch & Ward Utility vehicle on hire basis in the Day shift to attend day to day complaints of A. E. (Maintenance-II) Dept. in 'E' ward.

The Brihanmumbai Municipal Corporation (BMC) invites e-tender to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/ Companies registered under the Indian Companies Act 2013, the contractors registered with the Brihanmumbai Municipal Corporation, (BMC) in appropriate class as per old registration and appropriate class as per new registration and from the contractors/firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three months time period from the award of contract, otherwise their Bid Security i.e. E.M.D. (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.

#### **Bidding Process will comprise of THREE stages.**

The application form can be downloaded from Mahatenders Portal (<https://mahatenders.gov.in>) on payment of EMD of Rs. 24840/- & Scrutiny fees of Rs. 3300 + 18% GST. The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process & obtain login credentials to participate in the online bidding process.

- i) To download the application form, for those applicants not having vendor registration, need to apply first for vendor registration at the office of Account Officer (FAR), 3rd floor, Municipal Headquarter.
- ii) Followed by SRM login ID and password to be obtained from Central Purchase Department (CPD), Office at Byculla, Bakariadda, Mumbai.
- iii) For E-Tendering registration, enrollment for digital signature certificates and user manual, please refer to respective links provided in "Tenders" tab. Vendors can get digital signature from any one of the Certifying Authorities (CA's) licensed

by controller of certifying authorities namely Safes crypt, IDRBT, National informatics center, TCS CUSTOMS, MTNL, GNFC and e- Mudhra CA.
