The Brihanmumbai Municipal Corporation (BMC) invites e-tender to appoint Contractor for the above mentioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/ Companies registered under the Indian companies Act 2013, the contractors registered with the Brihanmumbai Municipal Corporation (BMC) under Mechanical/Electrical category Class, A'(as per registration rules 2015) and Class, A'(as per new registration rules, 2016) **and above as per new registration policy 2015 & 2016** (excluding those who are blacklisted or against whom FIR has been filed as per circular no. Dir/ES&P/1078/MC dt. 30/11/18) or those having equivalent or more work experience from BMC, Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings/Works, will be allowed subject to condition that, the contractors who are not registered with BMC, shall apply for registration with BMC (in same class, equivalent to BMC) within three months from the date of issue of work order failing which a penalty of 0.1% of contract cost or Rupees Ten Thousand, whichever is more, will be recovered / deducted from the Contractor's payment / bill by the executing department.

Bidding Process will comprise of THREE stages.

SECTION 2 ELIGIBILITY CRITERIA

2.1 Technical Eligibility Criteria

The tenderer(s) in their own name shall have satisfactorily executed the work of following nature in BMC /Semi Govt. /Govt. & Public Sector Organizations during last seven (7) years ending last day of month previous to the one in which bids are invited as a prime contractor (or as a nominated Sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied) The performance certificates for following works issued by the officer not below the rank of Executive Engineer of BMC shall be submitted.

1. Experience of operation and maintenance of SWD pumping stations.

i. One similar completed works each of value not less than Rs. 20,61,59,040/- or 18000 m3/hr $\,$

OR

ii. Two similar completed works each of value not less than Rs. 12,88,49,400/- or 11250 m3/hr

OR

iii. Three similar completed work of value equal and or not less than Rs.

10,30,79,250/- or 9000 m3/hr

AND

2. Hiring of pumping arrangement having minimum Three submersible dewatering pump of capacity 3000m3/hr during monsoon for Storm Water flood mitigation.

AND

3. The bidder shall submit MOU with Pump Manufacturer (OEM) in prescribed format.

2.2 Financial Capacity

The Tenderer shall have achieved an average annual financial turnover as certified by 'Chartered Accountant' equal to **Rs. 15,46,19,280 /-** in last three (3) financial years immediately preceding the Financial Year in which bids are invited.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

The Bidder shall submit the certificate of satisfactory completion of work from the user

Department of BMC / Semi Govt. / Govt. / Public sector organization, failing which their offer shall be treated as non-responsive and their Packet 'C' shall not be opened.

- A bidder (in case of a single entity) or a lead partner meeting technical qualifications (in case of a JV) shall be in existence for last 10 years , Authorized change in name & style shall be considered.

2.4 Bid Capacity (Not applicable)
The bid capacity of the prospective bidders will be calculated as under:

A = Maximum value of Engineering works executed in any one year (year means Financial year) during **the last five years** (updated to the price level of the Financial year in which bids are received at a rate of 10% per year, compounded annually) taking into account the completed as well as works in progress.

N = Number of years prescribed for completion of the Project/Works, **excluding monsoon period**, for which these bids are being invited. (E.g. 7 months = 7/12 year) For every intervening monsoon, 0.33 shall be added to **N**.

B = Value of existing commitments (only allotted works) on the last date of submission of bids as per bidding document and on-going works to be completed during the period of completion of the Project/Works for which these bids are being invited.

Note: The statement showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be attached along with certificates duly signed by the Engineer-in Charge, not below the rank of an Executive Engineer or equivalent

Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have:

- made misleading or false representation in the forms, statements and attachments submitted in proof of the qualification requirements; and/or
- Record for poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, or financial failures etc.
- submitted fake documents
