**Sub: Supply & Installation of electrical cable at Ghatkopar yard and overhauling of High Mast system at Powai steel yard & Maroshi Tunnel Shaft under AEOC(TM) division.**

The BRIHANMUMBAI MUNICIPAL CORPORATION (BMC) invites e-tender on ~~item~~ rate-/ Percentage Rate to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013, the contractors registered in Central or State Government / Semi Govt Organization / Central or State Public Sector Undertakings, will be allowed.

Bidding Process will comprise of THREE stages. The application form can be downloaded from Mahatender portal (<https://mahatenders.gov.in>). Bidder has to pay payment of **Rs.1557.60/- (Rs.1320/- + 18% GST) as a tender fee and Rs.500/-** as processing fee online on Mahatender portal. The applicants not registered with Mahatender are mandated to get registered (Vendor Registration) for e-tendering process & obtain login credentials to participate in the online bidding process.

i) To download the application form, for those applicants not having vendor registration need to apply first for vendor registration at the office of Account Officer (FAR), 4<sup>th</sup> floor, Municipal Headquarter.

ii) For e-Tendering registration, enrollment for digital signature certificates and user manual, please refer to respective links provided in 'Tenders' tab. Vendors can get digital signature from any one of the Certifying Authorities (CA's) licensed by controller of certifying authorities namely, Safes crypt, IDRBT, National informatics centre, TCS,CUSTOMS, MTNL, GNFC and e-Mudhra CA.

The Bidders will have to provide Earnest Money Deposit through the payment gateways while submitting the bids. The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit. The e-Tender is available on (<https://mahatenders.gov.in>) as mentioned in the Header Data of the tender.

As per THREE Packet systems, the document for Packet A & B is to be uploaded by the bidder in vendors' document online in Packet A, B and for packet C, bidder fill the data in data in item data tab in service line item via details & quoted his percentage figure. Packet A, B & C shall be opened on dates as mentioned in header data. All the responsive and eligible bidders if they so wish can be present at the time of opening of bids, in the office of Ex. Engineer.(H.W.)W.W. The Packet C shall be opened if bids submission in Packet A & B satisfies/includes all the requirements and same are found acceptable to the Authority.

The Municipal Commissioner reserves the right to reject all or any of the e- tender(s) without assigning any reasons at any stage.

## 1.1 Technical Capacity

The tenderer(s) in their own name should have satisfactorily executed the work of similar nature in BMC /Semi Govt. /Govt. & Public Sector Organizations during **last seven (7) years** ending last day of month previous to the date of issue of tender as a prime Contractor.

Bidder shall visit the site to get conversant with the scope of work, site constraint of the proposed work of "Supply & Installation of electrical cable at Ghatkopar yard and overhauling of High Mast system at Powai steel yard & Maroshi Tunnel Shaft under AEOC(TM) division." Site visit report shall be submitted / uploaded with duly sign & stamp by site in-charge / site engineer, as per the BMC format attached as per Annexure G (Pg.no. 117) along with packet B, falling which the bidder will be treated non responsive.

- a) **Three similar completed works each** of value not less than the value equal to **Rs. 1,65,200/-** for each work.(Excluding GST) **OR**
- b) **Two similar completed works each** of value not less than the value equal to **Rs. 1,92,700/-** for each work. (Excluding GST) **OR**
- c) **One similar completed work** of value equal and or not less than **Rs. 2,75,300/-** for each work. (Excluding GST)

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

**\*In case of ongoing works to be considered, the bidder must have received payment bills of 80% of the contract sum for the work/works executed last day of previous month to the one in which bids are invited.**

## 1.2 Financial Capacity

Achieved a average annual financial turnover as certified by 'Chartered Accountant' equal to minimum of **Rs. 1,94,900/-** of work in last three (3) financial years immediately preceding the Financial Year in which bids are issued.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

## 1.3 Similar Experience
