The Brihanmumbai Municipal Corporation (BMC) invites e-tender on ~~Item-Rate~~ / Percentage Rate Basis to appoint Bidder for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, proprietary / partnership firms / private limited companies / public limited companies / companies registered under the Indian company's act 2013. BMC scheduled registered bidders in electrical /mechanical category of MCGM class 'A' or above and with similar or higher class of public sector or Govt. or semi Govt. organization OR Registered bidders in public sector or Govt. or semi Govt. organization. The bidders who are not registered with BMC will have to apply for registering their firm within three months time period from the award of contract, otherwise their Bid Security i.e. **E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.**

Bidding Process will comprise of THREE stages.
