<u>Preamble</u>: Disaster Management Department of BMC is situated at 2nd floor of Annex building of Municipal head office, Mumbai. The centralized operation of disaster management is executed from this office. This department has installed IP based CCTV system at this office during the FY 2016-17. CSMC period of 5 years of this system has completed in Dec-2022.

This department has propsed to buyback the existing IP based CCTV system installed at this department and install new IP based CCTV system along with 4 years of CSMC after the completion pof DLP period of 1 year.

Scope of Work & Terms & Conditions

• Part A – SITC of IP Based CCTV System as per the specification and BOQ:

1. The bidders shall visit this office to assess the quantum of the work & terms and conditions and get well aquainted with entire Scope of work prior to submitting their offer.

The bidder shall be solely responsible for the discrepancy or any shortcomings in their offer thereafter. Also all the prospective bidders must upload site survey report duly signed by BMC site in charge during the visit in Packet A.

- 2. The entire work will be treated as a single job. There will not be any splitting of work on line item basis.
- 3. Lowest successful bidder has to complete the entire work mentioned against part A within 45 days from the issuance of Letter of Acceptance by this department Failing to which, a penalty of 1000/- per day will be levied.
- 4. This department will not provide any additional cost besides the cost quoted in the Packet 2 (Commercial Packet) submitted by the bidder.

- 5. The overall quantum of the work may vary to any extend and if the scope of the work is reduced to any extent, the contractor shall not claim any compensation and no payment will be made towards claim / compensation. If the quantum of the work get exceed tender amount, the contractor has to execute the work for additional amount at the same quoted rate. This point shall be considered while quoting the tender. however the payment will be made as per the actual quantity of BOQ utilised within contract limit.
- 6. The allied accessories / components, if required to make CCTV Surveillance system functional, shall be considered and installed without any extra cost. These accessories / components shall be installed as per BMC's approved procedure mentioned in USOR 2023. The contractor shall make the arrangement for referring USOR 2023 of BMC on their own before submission of tender.
- 7. All prospective bidders have to strictly followed the specifications mentioned BOQ.All the Cameras and allied equipments shall be strictly as per BMC's technical specifications. No Chinese brand cameras will be entertained / considered for fair competitiveness and organizational benefits. Any such proposals with Chinese brand equipments will be out rightly rejected. BMC have every right to demand Certificate of Origin for the cameras as well as their prime components.
- 8. The contractor shall carry out servicing, repairs and maintenance of CCTV Surveillance System to render trouble free uninterrupted services to the user department as per their requirements and recommendation of manufacturer.
- 9. The successful bidder shall visit the sites and submit the required architecture / plan
 - Drawings of complete surveillance system & the necessary interfacing arrangements, types of cables, cabling arrangement for the transfer of video images, data, signal etc. along with the specifications within 7 days from issuance of LOA.
- 10. The successful bidder should attend the break down calls whenever called by the department free of cost.
- 11. The contractor shall replace the spares of all the equipments related to the CCTV Surveillance System if found necessary at their cost during the entire contract period.

- 12. The contractor shall clean the premises of Control room, after carrying out servicing works& as when directed by site in charge. No material, dirt, caused during servicing shall be left in the room.
- 13. The contractor shall submit the copies of service reports to competent authority every month for the services rendered to CCTV Surveillance System.
- 14. The lowest successful bidder must have to conduct SITC of Fluke Testing of UTP Submission report after the installation of whole system.
- 15. The complete risk of human life while carrying out the service & maintenance of CCTV will be borne by contractor for their employees. Any damages caused to the municipal property/human being will be recovered from the bills of the contractor.
- 16. The payment shall be preferably made quarterly on Pro-rata basis after satisfactory service during the quarter period and on receipt of bill and service report from the contractor.
- 17. This contract is terminable by BMC by giving one calendar month's notice in writing of intention to discontinue it.
- 18. In case of dispute the Municipal Commissioner's decision will be final and binding on both the parties.
- 19. Municipal Commissioner is not bound for any relief/compensation if there is any reduction in the scope/quantum of the work or if no work is awarded at all.
- 20. Municipal Commissioner reserves the right to reject any tender or all tenders without assigning any reason therefore. Municipal Commissioner reserves the right to negotiate with the lowest bidder of each zone.

- 24. All the cameras and NVR shall be exclusively of same make in (Axis/Pelco/Matrix/Bosch) only. The same shall be necessarily certified by the Original Equipment Manufacturer (OEM)
- 25. Civil Work: The lowest successful bidder will have to carry out all the necessary civil works like trenching, cutting & filling of terminates, arrangement for cable pulling, pole foundation, etc. if required for the successful installation of above CCTV system. Also, this department will not borne any additional cost for civil work during installation of CCTV Camera at CIDM, Parel.
- 26. Remote Viewing facility: Contractor shall make arrangement so that live streaming of cameras shall be made available on web browser and on Mobile App to BMC officials.
- 27. The contractor shall extend full cooperation and interaction with other agencies at site, if involved.
- 28. While carrying out the work, if any damage is caused to any Municipal property, the same shall be restored by the contractor as per the guidelines from the BMC engineer. The cost of restoration / re installation shall be borne by the contractors.
