Insecticide Officer explained in brief the highlights of the tender.

The Chairman of M/s. Sairaj Berojgar Seva Sahakari Sanstha Ltd had sent the e-mail to Insecticide Office on 12.02.2026. Insecticide Officer read out the contents of the e-mail received regarding suggestion / requests about the said Tenders for Outsourcing of Thermal Fumigation activity through Vehicle Mounted Fogging Machines. Hence, Insecticide Officer told all the bidders to send e-mail to Insecticide Office regarding any doubts or queries relating to tender, Shri Anil Sarvade, the Manager of M/s. Janiv Swayamrjgar Seva Sahakari Sanstha Maryadit sent the e-mail to Insecticide Office on 13.02.2026.

It is already mentioned under Section 8- Bill of Quantities:- “Under no circumstances B.M.C.. will be liable to pay the difference in the increase of rates of all consumables, labour cost & other expenses whatsoever during the entire Contract period”. Insecticide Officer said that if the bidder is not registered with the Insecticide Officer for rendering Pest Control Services for Public Health, in the jurisdiction of Brihanmumbai Municipal Corporation, the bidder can produce the valid licence from the Govt. of Maharashtra, Department of Agriculture. Corrigendum will be published in this regard.
14		Shri. S. D. Shewale, Partner - Digvijay Enterprises asked whether a single bidder can apply for all 3 tenders of City, Eastern & Western Suburbs division together?	Insecticide Officer said that a single bidder can apply for all 3 tenders of City, Eastern & Western Suburbs division together subject to eligibility of bidder for all 3 tenders with his cumulative financial turnover.

But in Scope of Work on page no 26, its mentioned that the successful bidder has to provide Supervisor, skilled operator, driver for vehicle & helper.” He requested this office to modify or to delete Proforma IV on page no 92.	Insecticide Officer said that the successful bidder has to provide Supervisor, skilled operator, driver for vehicle & helper only. The said request is considered. Corrigendum will be done in this regard.
