### **Post Qualifying Criteria (Eligibility) :**

The Quotationer should specifically note the following post qualifying criteria towards their technical eligibility.

### **Financial:**

The average annual turnover of the quotationer shall be **Rs. 60,000/-** during the last three financial year i.e. **2019-20, 2020-21, 2021-22** from the due date of the quotation.

### **Technical:**

1 Quotationer who have experienced of procuring of spares/repairing of machineries in any Municipal corporation or govt./semi govt. sector in last three financial year. Documentary proof of work orders should be furnished at the time of collection of quotation copy. **The copy of the work order shall be attached with quotation documents.**

2) The above mentioned experience of having successfully completed such type of supply should be either of the following.

- a) Value of single job carried out at (1) above shall not be less than Rs. 1,05,000/-
- b) Value of two jobs carried out at (1) above shall not be less than Rs. 74,000/- each
- c) Value of three jobs carried out at (1) above shall not be less than Rs. 63,000/- each
