## **E-TENDER NOTICE**

**Subject:** ``Repairing of existing jogging track in Joseph Baptista Garden at Bhandarwada Hill Reservoir under A.E. (M.) W.W. City-II section. ``

The BRIHANMUMBAI MAHANAGARPALIKA (B.M.C.) invites e-tender on percentage rate basis to appoint Contractor for the above mentioned work from contractors of repute, multidisciplinary Horticultural organizations i.e. eminent firm, Proprietary / Partnership Firms / Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies" act 2013, the contractors registered with the BRIHANMUMBAI MAHANAGARPALIKA, (B.M.C.) in required Class and from the contractors/firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with B.M.C. will have to apply for registering their firm within three months' time period from the award of contract, otherwise their Bid Security i.e. E.M.D. (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty. (Please refer circular U/No Dir/ES & P/1078/MC dtd. 30.11.2018 for contractors who are not registered with B.M.C.

Bidding Process will comprise of THREE stages.

- i. To download the application form, for those applicants not having vendor registration, need to apply first for vendor registration at the office of Account Officer (FAR), 3rd floor, Municipal Headquarter.
- ii. Followed by SRM login ID and password to be obtained from Central Purchase Department (CPD), Office at Byculla, Bakari adda, Mumbai
- iii. The forms of Tender documents are available on the e-Tendering website <https://mahatenders.gov.in>. The aspiring Applicants will have to download Tender form, from the website mentioned above. The bidder has to fill in online format and upload information regarding Tender Online. Also, he has to download the Tender application form from website, fill it and upload the scanned copy of duly filled form, along with required documents.
- iv. For purchasing the Tender documents, the bidders will have to get registered with e-tender portal (<https://mahatenders.gov.in>) for the e-tendering process and obtain login credentials to participate in the online Tender process. The details of the same are available on <https://mahatenders.gov.in>. - v. The applicant has to pay Scrutiny Fee of Rs.6000/- + 18 % GST (9 % CGST+ 9 % SGST) (As per Circular No. CA/FRG/03/dt.11.05.2023) after opening of packet A & B but before opening of packet C in any CFC of BMC by challan.

While submitting duly filled tender document through <https://mahatenders.gov.in>, bidder needs to pay total EMD amounting to Rs. 32,000/- out of which bidder has to pay 10% E.M.D. online i.e. Rs. 3200/- (Rupees Three Thousand Two hundred only) & remaining

90% EMD i.e. Rs. 28,800/- (Rupees Twenty Eight thousand Eight Hundred only) in the form of Demand Draft (DD) payable to Brihanmumbai Municipal Corporation (BMC) physically to head clerk of EE (Maint.) MW. DD for part EMD shall be submitted to the head clerk of EE (Maint.) MW office by the next working day of bid submission and before opening of packet A. EMD is refundable in accordance to the relevant clause of bid document, except in the case of the selected Bidder whose Bid Security/EMD shall be retained. The Bidders will have to provide Earnest Money Deposit through the payment gateways and in form of Demand Draft as mentioned above while submitting the bids. The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit in the both form as mentioned above. The Applicant has to prepare & submit Tender Documents Online on or before last date of submission as mentioned in tender notice .
