

10 Penalty:-

If the Contractor fails to complete the works and clear the site on or before the Contract or extended date(s) / period(s) of completion, he shall, without prejudice to any other right or remedy of Municipal Corporation on account of such breach, pay as agreed compensation, amount calculated as stipulated below (or such smaller amount as may be fixed by the Engineer) on the contract value of the whole work or on the contract value of the time or group of items of work for which separate period of completion are given in the contract and of which completion is delayed for every week that the whole of the work of item or group of items of work concerned remains uncompleted, even though the contract as a whole be completed by the contract or the extended date of completion. For this purpose the term 'Contract Value' shall be the value of the work at Contract Rates as ordered including the value of all deviations ordered:

- Completion period for projects (originally stipulated or as extended) not exceeding 6 months: to the extent of maximum 1 percent per week.
- Completion period for projects (originally stipulated or as extended) exceeding 6 months and not exceeding 2 years: to the extent of maximum ½ percent per week.
- Completion period for projects (originally stipulated or as extended) exceeding 2 years: to the extent of maximum ½ percent per week. When the delay is not a full week or in multiple of a week but involves a fraction of a week the compensation payable for that fraction shall be proportional to the number of days involved.
- i) Completion period (as originally stipulated or as extended) not exceeding 6 months: 10 percent.
- ii) Completion period (as originally stipulated or as extended) exceeding 6 months and not exceeding 2 years: 7½ percent.
- iii) Completion period (as originally stipulated or as extended) exceeding 2 years : 5 percent.

The amount of compensation may be adjusted set off against any sum payable to the contractor under this or any other contract with the Municipal Corporation.

b) Penalty for inferior supply from defaulting contractors or suppliers:-

In case of the contractor at any time during the continuance of these present, supply of the material mentioned in Schedule is rejected because of inferior quality, the Commissioner reserves the right to levy penalty for such inferior supply from contract not exceeding 20% of the cost of supplied material.

11 Taxes

The quotationer shall quote inclusive of all taxes other than GST (Excluding GST), Levies, Duties, Cess etc as applicable at the time of bid submission. GST as applicable shall be paid separately on submission of bills/invoice.

Input Tax Credit of GST as available with the bidder will not be claimed separately by BMC.

However, while quoting the rates benefit of Input Tax Credit or Exemptions shall be passed on to the BMC by way of equivalent reduction in quoted price.

"Chapter XXI- Miscellaneous, section 171(1) of GST Act, 2017 governs the 'Anti Profiteering Measures' (APM)As per the provision of this section, 'Any reduction in rate of tax on any supply of goods or services or the benefit of input tax credit shall be passed on tothe recipient by way of commensurate reduction in prices. 'Accordingly, the contractor should pass on the complete benefit accruing to him on account of reduced tax rate or additional input tax credit to BMC. If contract cost exceeds 2,50,000.00 (Excluding GST), 2% GST TDS (1% CGST + 1% SGST or 2% IGST) will be deducted at source as per circular CA(Treasury) /Cash / City/ 20 dtd. 05.10.2018

- a) Firms having common partnes /proprietor or who are connected with one another either financially or as principal and agent or master and servant or closely related to each other such as husband and wife, father/mother and minor son/daughter and minor brother /sister shall not quote separately under different names or establishment for the same contract.
- b) If it is found that firm as described in clause 13a) have quoted separately under different names and establishment for the same contract, the quotation shall stand rejected and quotation deposit shall be forfeited. Any contract entered into under such condition will also be liable to be canceled at any time during its currency. In addition, such firms/establishments shall be liable at the discretion of the Municipal Commissioner for further penal action including blacklisting.
- c) If it is found that closely related person as in clause 13(a) have submitted separate tenders/quotations under different names of firms /establishments but with common address for such firms/establishments and/or if such firms/establishments though they have different addresses, are managed or governed by by the same person/persons jointly or separately, such quotation shall be liable for action as in clause No. 13a) including similar action against the firms/establishments concerned.
- d) If after award of contract, it is found that accepted quotation violated any of the clause 13(a) to 13(c), the contract shall be liable for cancellation at any time during its currency in addition to penal action against the contractors as well as related firms/establishments.

SCOPE OF WORK & TECHNICAL SPECIFICATIONS

INTRODUCTION:

The Pise weir is constructed on the Bhatasa river which is near Pise pumping station. As per daily demand of MCGM, water releases from Bhatasa Dam which is about 48 Kms from Pise weir. Thus, monitoring the weir level hourly, putting daily demand of water in order to maintain the desired water level at Pise weir is very important for uninterrupted water supply to city of Mumbai.


The weir level of Pise dam is measuring by scada system & record of the same is maintained hourly by operation section of pumping station. If the SCADA system fails then it becomes difficult to record the actual weir levels. In monsoon season the water level rises frequently due to flooding in Bhatasa river. The pneumatic system installed at Pise Weir needs to deflate above 33.25 MTHD to avoid the damage to Pneumatic system. In such case if SCADA system malfunctions/ fails then it will be difficult to take decision of deflation in rising trend.

Thus it is necessary to provide alternate arrangement for measuring water level of Pise weir. Hence, it is necessary to install, a water level scale (approximately 10 meter length) of stainless steel material on the structure of sand extruder gates.

SCOPE OF WORK

<u>Installation of stainless steel water level scale (10 meter approximate) on the structure of sand extruder gates:</u>

- 3. SS 304 steel plate should have total length 10Mtr, width 200mm and thickness Min 3 mm shall be fastened to existing M.S. structure beside pneumatic gate no.1
- 4. Top level of sand extruder gate structure is 39 MTHD. Hence top level of water level scale shall be 39 MTHD & bottom level shall be 29 MTHD (i.e. Total length of scale-10 Mtr.)
- 3. The scale shall be divided by engraving lines in dark colours at 10 cms gap. All lines shall be indicated by using colorful radium. The details are shown in diagram.
- 4. Scale shall be fixed with SS fasteners.
- 5. Numbering shall be provided at a distance of 1 mtr length.
- 6. Scale shall be provided in suitable pieces for the purpose of proper fitment.
- 7. The contractor shall visit at site & inspect the location of fixing the water level indicator before quoting for the offer.
