- 1) Sterile Barrier Foam Dressing, Impregnated with POLY DADMAC (Diallyl Dimethyl Ammonium Chloride). Broad Spectrum Antimicrobial with Non Leaching. Non Resistance & Non Toxic properties (10cm X 10cm).
- 2) Essential to be used in advanced wound care management and Higher exuding wounds can be used in following indications First and Second degree burn, Venous ulcers, Pressure Ulcers, Diabetic Ulcers, Injuries (blunt & sharp). Etc.
- 3) Sterile Barrier Foam Dressing must have below Certification.
  - US FDA CERTIFIED
  - ISO 11135:2014 MEDICAL DEVICES
  - ISO 13485 MEDICAL DEVICES
  - CE CERTIFIED
