1. Following documents duly attested should be enclosed with e-quotation

I. GST Registration Certificate.

II. PAN Documents of the Co. / Proprietor / Two Directors with Color Photos.

2. The offer should be inclusive of all taxes. (i.e. GST / Delivery charges etc) subsequent increases in the price /cost due to any reasons will not be entertained.

3. Bifurcation of taxes should be submitted on letterhead with HSN code along with name of items. (Basic rate should not be disclosed any indication of basic rate will lead to rejection)

4. Supply should be made at Medical Store K.E.M.Hospital, Parel Mumbai-12 in full quantity at once.

5. EMD Should be paid online on or before of the due date & time.

6. The payment will be made within 30 days after receipt of complete supply.

7. Delivery / Penalty:-

I. Supply should be made within 30 days of the receipt of Purchase order.

II. For delayed supply – ½ % penalty per day or part thereof after the expiry of the delivery period subject to maximum 10%.

III. Failure of the supply, EMD will be forfeited and action deemed fit will be taken against supplier.

IV. Variation as per specifications – if material get rejected, the cost of the said material will be recovered from the Quotationer / supplier.

8. On Finalization of Quotation at time of supply indemnity bond upon 200/- rupees stamp paper is required.

9. On Completion of supply Contract Bond upon 500/- Rupees Stamp Paper is required. (P.O. of above Rs.50,000/- to Rs.3,00,000/-)

10. As per Circular no. 10318 Dt. 24.03.22 successful Quotationer should pay towards Legal & Stationary Charges. (P.O. of above Rs.50,000/- to Rs.3,00,000/-)

11. Quotation fee of Rs. 220 + 18% GST has to be paid online on given date and time.

12. Action deemed fit including blacklisting will be taken if it is found that:-

I. Forged documents are submitted OR

II. If it becomes responsive on the basis of submission of bogus certificate OR

III. If the supply received is substandard quality / non supply.

13. Sample will be ask from 1st & 2nd Lowest bidders after the opening of “C” packet and need to submit sample along with Quality Control Test Report immediately on next day, failing which offer will not be considered and action will be taken

14. Incomplete offer will be left out of consideration.

15. “MCGM supply not for sale” is compulsory on the product. No MRP on the product.

16. Minimum half of the expiry period should be available for user department from the date of delivery and unused drugs or expired drugs will be replaced.

17. The drugs / medicine shall fulfill all the requirements set out as per WHO GMP standard.

18. copy of Valid Drug Mfg Lic / Import Lic. Along with approved Product List

Above (17 & 18) Need to submit the documents (Pkt A & Pkt B) as per check list given failing which offer will be treated as invalid

19. Signature & Company Seal/Stamp is required on quotation form.
