EXPRESSION OF INTEREST

The Public Health Department of BMC expresses its interest to all individuals, doctors, organizations and agencies to appoint panel of Radiologist for Sonography, routine and congenital anomaly scan services of pregnant women in maternity homes. Interested respondents may submit their Letter of Interest to the Office of the Executive Health Officer, 3rd Floor, F/South Ward office Building, Dr. B. A. Road, Mumbai 400012 till 10th Oct 2022 by 1.00 pm. by mail (usgmcgm@gmail.com) along with the required documents.

Terms & Conditions for outsourcing sonography services in maternity home/ Peripheral Hospital / UPHCs.

1. The appointment of NGO/Trust/ Company will be for 2 years on temporary basis.
2. Appointment is only for doing routine, emergency obstetric sonography and congenital anomaly scan of ANC mothers in Municipal maternity homes / Peripheral Hospital / UPHCs.
3. Days and Timings are as per need and convenience of patients attending in maternity homes as decided by the Maternity Home Medical Officer Incharge.
4. The charges for routine obstetric sonography should not be more than Rs.180/- and Charges for congenital anomaly scan should not be more than Rs. 600/-, respectively (same as Colour Doppler rate as per approved circular प्रवैअवखाप्र/माआसे/2632 दि.29.05.2018.)
5. Sonologist has to work in BMC set up on available make of Sonography machines.

6. The Sonologist required for routine USG and congenital anomaly scan will be appointed by selected NGO/Trust/Company. The Salary/Honorarium, PF Tax implication etc of Sonologist will be borne by NGO /Trust/Company.
7. BMC MSR rules and regulation will not be applicable for Employees/Radiologist appointed by NGO/Trust/Company nor they can claim / insist for permanent employment from BMC.
8. The payment will be done at the end of month after verification of report by Incharge officer of respective maternity homes with due process as applicable.
9. The payments will be released in the name of NGO/Trust/Company.
10. All BMC rules, regulations and Laws are applicable for NGO/Trust/Company.
11. F form with result/report to be filled and submitted by NGO/Trust/Company
12. Monthly report to be submitted to MO I/C of maternity home by Sonologist in the prescribed format on last day of every month without fail.
13. PCPNDT registration and any other registrations required for above sonography, congenital anomaly scan etc is mandatory and it is responsibility of NGO/Trust/Company to obtain registration from concerned authority.
14. Quality of services would be supervised by the Public Health Department periodically. If gross discrepancy is noted in the reports the contract may be terminated after due procedure by the Public Health department.
15. The NGO/Trust/Company/Individual will bear the medicolegal responsibility of the ultrasonography reports.

Selection criteria

1. Sonologist should be available for emergency cases also.
2. In case the BMC USG machine is not available / not working for any reason, the service provider should arrange the alternate USG machine/ probe at that Maternity Home on temporary basis at their own cost till other arrangements are made.
3. Experienced service provider will be given preference.
