4. The Quotationer shall have work experience with the BMC for supply of above material Quotationer shall submit Copy of purchase order of BMC in last 1 years.

The successful quotation shall give the undertaking of best price (Rs.200/-Stamp paper) duly notarized by notary public/first class magistrate in the sub joined form Respectively and affidavit of GST as per Annexure-A (Rs.500/-stamp paper) with that he must prepare contract Agreement on Rs 500/- Stamp paper.

12. Manufacturer should be accredited by Ministry of Drinking Water and Sanitation.

14. Manufacturer should have conducted one successful trial run of his product in the BMC and the same should have positive remarks by concerned officer of that ward it positive comments.
