4. The Quotationer shall have work experience with the BMC for supply of above material Quotationer shall submit Copy of purchase order of BMC in last 1 years.

The successful quotation shall give the undertaking of best price (Rs.200/-Stamp paper) duly notarized by notary public/first class magistrate in the sub joined form Respectively and affidavit of GST as per Annexure-A (Rs.500/-stamp paper) with that he must prepare contract Agreement on Rs 500/- Stamp paper.
6. The rate quoted shall be firm and no variation will be allowed subsequently on any account. Quotation shall submit his true copies of Govt. certified test report. Manufacturing license issued by BMC.

7. Authorization letter from Manufacturer of Septic Tank treatment salutation will be required as per the Format given in Annexure.

9. Manufacturers factory should be registered and certified by Ministry of Science and technology Department of Scientific and industrial Research

11. Product should be certified by Institute for Industrial Research and toxicology as non Toxicant Safe to Use.
12. Manufacturer should be accredited by Ministry of Drinking Water and Sanitation.
13. Manufacturer should be ISO 9001:2015 and 14001:2015 certified.
14. Manufacturer should have conducted one successful trial run of his product in the BMC and the same should have positive remarks by concerned officer of that ward it positive comments.
15. Factory visit should be arranged by the participants to assess supply capability and material testing.
