The successful quotation shall give the undertaking of best price (Rs.200/-Stamp paper ) duly notarized by notary public/first class magistrate in the sub joined form Respectively and affidavit of GST as per Annexure-A (Rs.500/-stamp paper) with that he must prepare contract Agreement on Rs 500/- Stamp paper.
