SPECIFICATIONS OF ANTIMICROBIAL CONTAMINATION CONTROL FLOOR MAT

- A. It should be washable sticky mat. This mat helps remove the dust particle from personnel shoes, clothes and trolleys entering into your clean room
- B. Size 4 Feet x 2 feet
- C. It may be cleaned with any neutral detergent and having life of 2-3 years on good maintenance
- D. It can be moved not a permanent installation.
- E. It should have antimicrobial properties to stop contamination with dust control (Bio master)
- F. Working Temperature: 0-50 Deg C.
- G. It should not be peel off mat and must be fire retardant
- H. IT SHOULD HAVE RESISTANT TO MOST COMMONLY USED CHEMICALS IN THE HOSPITAL.
- I. It should take load resistance up to 40kg/cm².
- J. User list with details of installation should be provided
- K. It should confirm to the standards set by ISO22196:2011
- L. Sample should be submitted done day before due date up to 2.00pm. Otherwise the Tenderer will be treated as non responsive without any intimation.
- M. Sample must be approved by officers before opening C packet.
