### Post Qualifying Criteria:

- 1) The quotationer should have carried out similar kind of work of Repairs/ Testing/ Oil filtration of power transformer in last 7 years within Gov. / semi govt./ BMC and shall produce the evidence of the same along with quotation.
- 2) The quotationer shall licensed electrical contractor of industry, energy & labour department of Maharashtra state Government.

The E.M.D. Receipt No. and date shall be clearly mentioned on the envelope. Only Registered Municipal Suppliers (in case of quotation for supply),

having revised Standing Deposit according to their class & category, are exempted from payment of Earnest Money Deposit. However, it is mandatory on the Registered Municipal Suppliers to mention Standing Deposit Receipt No. on the quotation envelope and also enclose attested photo copy of the Standing Deposit Receipt alongwith the quotation.
